INVOCATION by Pastor Andy Oliver, Allendale United Methodist Church, St. Petersburg.**PLEDGE OF ALLEGIANCE**

Chair Eggers related that a large group of family members, colleagues, and others gathered today at a funeral service in remembrance of Pinellas County Sheriff's Deputy Michael J. Magli, killed on February 17 in the line of duty. He thanked Officer Magli for his service and asked for a moment of silence in his honor.

PRESENTATIONS AND AWARDS

1. Partner Presentation:
- Mike Sutton, President & Chief Executive Officer, Habitat for Humanity of Pinellas and West Pasco Counties

Mr. Sutton referred to a PowerPoint presentation and provided the annual update regarding Habitat's accomplishments and upcoming projects, noting that despite the pandemic, the organization had a record year, completing 61 homes of a total 663 built since the beginning of the program in 1985; and that development and transformation of the Greater Ridgecrest Area continues. He thanked the County for the partnership and assistance in obtaining over \$3.3 million in State Housing Initiative Partnership funding over the years; whereupon, he presented the Commissioners with a cardboard check for \$959,888, signifying the property taxes paid by Habitat homeowners in 2020, and brief discussion ensued.

2. Partner Presentation:
- #PurePinellas by Commissioner Justice

Commissioner Justice introduced the item and the Clearwater Marine Aquarium representatives, CEO Frank Dame and Sea Turtle Conservation Program Supervisor Lindsey Flynn.

Mr. Dame expressed appreciation for the County's partnership and support; whereupon, he referred to a PowerPoint presentation and spoke about the aquarium's history and mission, the impact of Dolphin Tale films, featuring dolphins rehabilitated at the aquarium, on its visitation and its current programs, including whale rescue and monitoring, sea turtle conservation, research, and education.

Ms. Flynn referred to the PowerPoint presentation regarding the sea turtle conservation program and discussed the types of turtles nesting on the county beaches and the nesting process. She indicated that artificial light has a harmful effect on hatchlings and adult turtles, disorienting them from the water; and that the aquarium staff, in partnership with a non-profit Florida organization, is working with beachfront property owners to retrofit properties with sea turtle friendly light that does not attract turtles; whereupon, she demonstrated the difference between the artificial white light and the sea turtle friendly LED light, noting that the latter provides additional benefits of energy cost saving, improved visibility, and compliance with sea turtle lighting ordinances.

Commissioner Justice indicated that he joined the Mayors of St. Pete Beach and Madeira Beach this morning in receiving the Tripadvisor's Travelers' Choice Awards for the best beaches in the U.S., with St. Pete Beach ranking at the top and Madeira Beach, Treasure Island Beach, and Clearwater Beach in the top 20; whereupon, Chair Eggers commented on the importance of beach renourishment for tourism and other purposes.

LOCAL STATE OF EMERGENCY

3. Local State of Emergency.

Florida Department of Health in Pinellas County Director Dr. Ulyee Choe discussed current COVID-19 trends and statistics, indicating that overall, the case count and positivity rate numbers have been declining over the last two months; whereupon, he provided an update regarding the vaccination efforts, including supply, distribution, registration, vaccine administration sites, and numbers of vaccinated residents.

During discussion and responding to queries by the members, Dr. Choe, Mr. Burton, and Assistant County Administrator Lourdes Benedict provided further information on the following and related topics pertaining to vaccination:

- Registration for elderly residents without a mobile phone or an email
- Equity for minorities
- The need to register
- Johnson and Johnson vaccine
- Vaccine supply
- Distribution priorities and phases
- Public messaging
- Comparison to other counties
- Vaccine administration sites

During discussion and in response to concerns expressed by the citizens, Commissioner Long spoke on COVID-19 vaccination at Publix Super Markets. Chair Eggers and Mr. Burton noted the challenges relating to the vaccine supply issues and managing the distribution process, and Chair Eggers emphasized the need to continue community outreach efforts and seek alternative solutions.

Responding to queries and comments by the members, Mr. Burton indicated that a report by a group of local health professionals identifying a criteria for lifting the mask mandate was emailed to the Commissioners and posted on the County website. Dr. Choe clarified that while the overall trend for COVID-19 case count and percent positivity appear to decline, there was a minor increase over the last seven days, and Mr. Burton remarked that while the numbers are going down, the virus remains a concern for the community; and that a conversation regarding the mask mandate is welcome.

Commissioner Justice noted that following a conversation with Mr. Hayes and VSPC's Digital Communications Vice President Leroy Bridges, he has an increased comfort level with regard to the project and its potential for success.

Attorney White discussed the redistricting process and potential issues with seating the Redistricting Board (Board) related to the delay of U.S. Census Bureau data, noting specific aspects of the BCC Charter with regard to Board timelines. She related that state law requires redistricting to be completed during odd-numbered years.

Discussion ensued regarding options for selecting the Board members given the current inability to finalize timelines; whereupon, Chair Eggers stated that confirmation of availability will be obtained from those whom have expressed an interest to serve; and that an update will be reported at a future BCC meeting.

Attorney White indicated that she will hire outside counsel to serve the Board so that she remains available to advise the BCC regarding redistricting matters.

COUNTY ADMINISTRATOR

30. County Administrator Reports.

Mr. Burton reported that the Dunedin City Commission will be presented the acquisition of the Gladys Douglas Hackworth property at their meeting this evening, and that the County's agreement will be presented for ratification to the BCC at the March 9 meeting.

32. Pinellas County Youth Advisory Committee Update.

Chair Eggers expressed his appreciation to Commissioner Peters and Executive Aide Ashley Overend for their work with the Youth Advisory Committee (YAC) and introduced YAC Chair and Vice-Chair, Madelyn Marcos and Dillon Vann, respectively. Ms. Marcos and Mr. Vann referred to a PowerPoint presentation titled *Presentation to the Pinellas County Board of County Commissioners* and discussed the following topics:

- Operations and COVID-19
- Educational meetings with local officials and businesses, including the Supervisor of Elections Office, Sheriff's Office, and the Florida Dream Center
- Short-term community service projects, highlighting 4-H Farm Days Seeding the Future events and Wreaths Across America at the Bay Pines National Cemetery
- Youth mental health awareness long-term project focusing on education, awareness, and policy assessment
- Expansion of social media presence

Responding to a query by Commissioner Long, Mr. Vann and Ms. Marcos discussed their plans for college and their efforts regarding mental health advocacy within their high schools, noting that they have focused on reducing the stigma surrounding youth mental health and have sought peer feedback.

Commissioner Peters thanked the members for the presentation, commenting on the passion that they have shown for the mental health platform, noting that she believes their generation will be the one to remove the stigma surrounding mental health and no longer tolerate the lack of mental health services available to those in need, thereby moving mental health into the healthcare system mainstream. Discussion ensued; whereupon, she expressed her appreciation to Alyssa Bowers with 4-H and to Ms. Overend.

33. Case No. ZON-21-01 (Katie Hodges)

A request for a zoning change from R-A, Residential Agricultural to R-R, Rural Residential on approximately 1.59 acres located at 4720 Roberts Road in Palm Harbor.

Resolution No. 21-15 adopted approving the zoning change. The Local Planning Agency recommended approval of the request, and staff concurred. No correspondence has been received. No citizens appeared to be heard.

Principal Planner Michael Schoderbock referred to a PowerPoint presentation containing maps and photographs of the area, pointed out the location of the subject property, and described the surrounding land uses, indicating that the property is non-conforming as Residential Agricultural requires a minimum of two acres; whereupon, he noted that the applicant intends to construct two houses on the property.

A request for a zoning change from R-R, Rural Residential to R-3, Single Family Residential and a land use change from Residential Suburban to Residential Low on approximately 2.18 acres located at 1736 Winchester Road in unincorporated Largo.

Hearing continued until April 27, 2021. The Local Planning Agency recommended approval of the request, and staff concurred. Sixty-two letters, 19 emails, and 13 voicemail messages in opposition have been received, along with two emails expressing concern and one email in support of a continuance.

Zoning Manager Glenn Bailey stated that the applicant has requested a continuance to April 27; and that the applicant is present.

Attorney White indicated that due to the case being quasi-judicial, the Board must allow public comment on any action taken; that if a continuance is approved, she recommends allowing comment solely regarding the continuance since changes could occur with the case; and that any motion made should include the continuance date of April 27 to negate the need to re-advertise.

Commissioner Justice moved, seconded by Commissioner Long, that the case be continued until April 27, 2021.

Chair Eggers reiterated that public comment would be limited to the continuance; whereupon, he called upon the applicant. Dushyant Gulati appeared and provided information regarding the request, indicating that it would allow him to continue working with concerned neighbors.

An Ordinance of Pinellas County, Florida, providing for the amendment of Chapters 138 - Zoning and 154 - Site Development, Right-of-Way Improvements, Subdivisions, and Platting of the Pinellas County Land Development Code and providing for the adoption of the Transportation Design Manual.

First public hearing. The Local Planning Agency recommended approval of the request. No correspondence has been received. No citizens appeared to be heard. Second public hearing to be held April 27, 2021.

Zoning Manager Glenn Bailey referred to a PowerPoint presentation and provided a brief overview of the proposed amendments, noting that they allow for additional clarifications, flexibilities, and streamlined and consolidated regulations; whereupon, Public Works Engineering Section Manager Tom Washburn related that the proposed Transportation Design Manual contains transportation and traffic facility dimensional requirements from the Land Development Code; and that it contains standards for use by County engineers and the development community, and discussion ensued.

Responding to the Chair's call for public comment, Joe Farrell, Clearwater, expressed his concerns.

36. Resolution addressing lien forgiveness. (Companion to Item Nos. 37, 38, & 39)

Resolution No. 21-16 adopted authorizing the Code Enforcement Division to partially forgive existing liens. Two emails from one individual expressing his opinions have been received. No citizens appeared to be heard.

Building and Development Review Services Director Blake Lyon indicated that Item Numbers 36 through 39 are companion items; whereupon, Attorney White recommended that the Clerk introduce each item concurrently so that staff can conduct a presentation to encompass all items, to which the Clerk complied; and that the Board take a separate vote for each item.

Mr. Lyon indicated that following consultation with the County Attorney's Office, the proposed ordinance under Item No. 39 is not needed; and that the desired outcomes related to this item can be achieved through the County Attorney.

Mr. Lyon provided an overview of the requests and provided information regarding the current lien and accrual process, noting that lien accruals can exceed the value of a property. He related that the proposed ordinances and resolution incorporate consistent methodology with the intent of increased likelihood of property reinvestment, improvement, and redevelopment by reducing the monetary barrier through partial lien forgiveness, lien capping, and demolition and condemnation of blighted properties; and that the demolition and condemnation ordinance will allow for quicker resolution of properties which pose life safety and blight conditions.

Responding to a query by Commissioner Seel, Mr. Lyon indicated that lien settlement amounts will equate to direct costs expended by the County, as opposed to property value; and that it is estimated the County will receive between \$10 million and \$30 million in lien settlements.

Commissioner Flowers commented that she is supportive of the proposals; and that for future consideration a noise abatement process may result in a quicker and more cost-efficient result in some cases.

Mr. Lyon further indicated that an additional aspect of the lien settlement program is the development of a hardship committee; that the committee will review cases involving unforeseen circumstances such as predatory lending or loss of employment; and that the committee can recommend a further reduced lien settlement.

A motion was made by Commissioner Flowers, seconded by Commissioner Seel, that the item be approved. The motion carried by the following vote:


- 39. Ordinance amendment addressing the delegation of authority for litigation. (Companion to Item Nos. 36, 37, & 38)
