<b><u>6:00 P.M.</u></b>	<b>ANNOUNCEMENT of Public Hearings on the FY22 Tentative Millages and Tentative Budgets.</b>
<b>CHAIRMAN</b>	Has any correspondence been received regarding the tentative millages and tentative budget?
<b>CLERK</b>	<i>[Clerk responds to the question]</i>

**I.) OPEN PUBLIC HEARING**

<b>CHAIRMAN</b>	Good evening. Tonight’s public hearing is the first of two public hearings for the consideration and adoption of the FY22 millages and budgets. Before we get started, I’ll walk through the sequence of events for tonight.
	<b>1)</b> The County Administrator will present changes to the Proposed Budget since it was originally presented to the Board on July 13th.
	<b>2)</b> The County Administrator will provide a Budget Overview presentation that incorporates these changes.
	<b>3)</b> We will accept public comment on the following property tax levies and budgets by the following taxing authority classification: <ul style="list-style-type: none"> <li>• the <b>BCC County-wide levy</b> for the <b>Pinellas County General Fund</b>, and the County levy supporting the <b>Health Department Fund</b>,</li> <li>• the levies for <b>Dependent Special Districts and Unincorporated Area "Municipal Services Taxing Units"</b> that, going forward, will be referenced as <b>“MSTUs”</b>.</li> </ul>
	<b>Dependent Special Districts</b> include the Emergency Medical Services Authority and Pinellas Planning Council, and <b>MSTUs</b> include the Unincorporated Area Municipal Services Unit, Public Library Services District, Palm Harbor Community Services District, Feather Sound Community Services District, East Lake Library Services District, East Lake Recreation Services District and the Special Fire Protection Districts.
	<b>4)</b> If you wish to speak regarding the Tentative millages and Tentative budgets, you should have filled out a blue card. If you have not yet filled out a card and wish to speak, please see the staff seated by the entry door and they will assist you. For all the preregistered online participants, you will be instructed at the proper time to raise your hand in the virtual meeting.
	<b>5)</b> After hearing all public comment, I will ask the Board if they recommend any further changes to the Tentative millages or Tentative budgets. If so, I will ask the Board for a motion and a vote to adopt any changes.
<b>6)</b> Finally, we will adopt the resolutions for the <b>FY22 Tentative millage rates and Tentative budgets</b> , which will be the basis for the <b>final budget public hearing</b> that will be held on <b>Tuesday, September 21st at 6:00 p.m.</b> In accordance with Florida Statutes, the <b>Tentative millage rates</b> will be adopted first and then the <b>Tentative budget</b> will be adopted for each taxing authority.

<p align="center"><b>CHAIRMAN</b></p>	<p><b>7)</b> Before we begin this public hearing, if anyone has specific questions or concerns regarding the <b>assessed value of their property, exemptions or classification related to your property, or information on the TRIM notices</b>, tonight we have here with us Kevin McKeon, the Deputy of Assessment Administration, from the Pinellas County Property Appraiser's Office. If anyone would like to speak with him, please follow him at this time, and he will answer your questions. For those attending virtually, please contact the Pinellas County Property Appraiser's office at 727-464-3207 Monday through Friday 8AM to 5PM or email mike@pcpao.org.</p> <p><b>8)</b> Florida Statutes also provide that a taxing authority may adopt the tax levies and budgets of all its dependent special taxing districts and MSTUs by a <b>single unanimous vote</b>. However, if a member of the general public requests that the tax levy or budget of a dependent special tax district or MSTU be separately discussed and separately adopted, we will then discuss and adopt that District's tax levy and budget separately.</p> <p><b>At this time, does any member of the general public attending the meeting in-person request separate discussion or separate adoption of a tax levy or budget of any dependent special district or MSTU?</b></p>

For those of you that have preregistered to speak online, if you are requesting separate discussion or adoption, please press star 9 on your telephone, or raise your hand virtually in the zoom meeting. Do not raise your hand if you have questions or comments about tentative budgets or tentative millages at this time.</p>

<p align="center"><i>(Note to CHAIRMAN)</i></p>	<p><i>(If no one requests separate discussion/adoption of tax levy or budget, continue with this script; OR if request is made for separate adoption, go to <u>Alternate Script - Adoption by Separate Resolutions</u>. <p align="center"><b>CHAIRMAN</b></p>	<p><b>9)</b> Since we have not heard from anyone requesting separate discussion and separate adoption of any dependent special districts or MSTUs, we will proceed with adoption of the Tentative millages and Tentative budgets for the dependent special districts and MSTUs by <b>single unanimous vote</b>. <b>We will now open the first official public hearing on the FY22 Millage Rates and Budgets.</b></p>
<p align="center"><b>CLERK</b></p>	<p>This public hearing is being held in accordance with Chapters 129 and 200 of the Florida Statutes. The meeting has been duly noticed by the Property Appraiser's mailing of the <b>TRIM Notice</b>.</p>
<p align="center"><b>CHAIRMAN</b></p>	<p>Thank you. We, the Board of County Commissioners, as taxing authority for the <b>BCC County-wide, Dependent Special Districts and MSTUs (as previously referenced)</b> will now proceed with the public hearings.</p>
<p align="center"><b>ADMINISTRATOR</b></p>	<p>In accordance with Florida Statutes, I want to publicly note that the percentage increase in the millage rate for all budgets over the rolled-back rate, based upon the maximum rates on the TRIM Notice and subsequent decreases to such rates, to fund the FY22 Tentative Budget is a <b>1.93% increase over the aggregate rolled-back rate</b>. The primary purposes for the <b>increases in millages over the rolled-back rates</b> are due to the following:</p>

<b>ADMINISTRATOR</b>	<p>In the General Fund, including Unincorporated Area MSTU, and in the Emergency Medical Services Authority, revenue increases are required to support personnel and operating expenditure levels that are driven by inflationary factors. In the Pinellas Planning Council, revenue increases are required for the same purposes, as per the request of Forward Pinellas.</p> <p>In the Public Library Services District MSTU, the Palm Harbor Community Services MSTU, the Feather Sound Community Services MSTU, the East Lake Library Services MSTU, East Lake Recreation Services MSTU and five Special Fire Protection Districts, revenue increases are needed to support increased expenditures by the agencies providing services for those districts. In the other seven Special Fire Protection Districts, the revenue decreases are due to those districts having sufficient reserve levels to provide for future planned capital along with property values that can support annual operations.</p> <p>CHAIRMAN, before we begin the FY22 Budget presentation, I want to note that a schedule of changes to the Proposed Budget was distributed to the Board on <b>September 2, 2021</b> and attached to the agenda packet available online. Modifications include both changes discussed at BCC meetings or work sessions and technical adjustments related to accounting presentation, updated information, corrections, and other minor changes. **IV.) ADOPTION OF RESOLUTIONS -  
TENTATIVE MILLAGE RATES AND TENTATIVE BUDGETS**

<b>CHAIRMAN</b>	<p>Now that we have received all public comment, the Board must now consider the Resolutions to set the Tentative millage rates and Tentative budgets. As stated earlier, we will <b>adopt the Tentative millage rates and Tentative budgets</b> in the following sections:</p> <p>(1) BCC County-wide, to include the General Fund and Health Department, and (2) Dependent Special Districts and MSTUs</p> <p>The resolutions adopting the millages and budgets for the dependent special districts and MSTUs require a <b>unanimous vote</b>. If a unanimous vote is <b>not</b> received, we will need to adopt each of these <b>separately</b>.</p>
	<p>These Resolutions adopt the <b>Tentative</b> millage rates and <b>Tentative</b> budgets. The Resolutions for adopting the <b>final</b> millage rates and budgets are scheduled for the next <b>public hearing on Tuesday, September 21, 2021 at 6 p.m.</b></p> <p><b>I will now ask the County Administrator to proceed with the readings and for Communications to display Schedule A that will be referenced during the readings and votes.</b></p>
<i>(Note to Communications)</i>	<i>Please display Schedule A on the screen and leave on the screen until both sets of votes are completed.</i>
<b>ADMINISTRATOR</b>	<p>Thank you, CHAIRMAN. I will announce each Resolution separately for the Board's action. Per Florida Statutes, the Board will vote on the Tentative millage first and then the Tentative budget for each taxing authority. We will start with the consideration of the Pinellas County General Fund millage.</p> <p><b>1. For the <u>General Fund</u>:</b></p> <p>a. I recommend adoption of a millage levy of <b>5.1302</b>, which reflects a <b>2.56% increase</b> over the rolled-back rate of <b>5.0023</b>.</p>
<b>CHAIRMAN</b>	<p>May I have a motion to adopt the Tentative millage?</p> <p align="center"><b>(MOTION &amp; VOTE)</b></p>
<b>ADMINISTRATOR</b>	I recommend adoption of the Tentative budget.

This notice will be published in the Tampa Bay Times on September 19th. The second and final Budget public hearing will be on Tuesday, September 21st at 6:00 p.m.
