Dear Chairman Eggers and Board of Pinellas County Commissioners,

During the Board of Commissioners meeting on Tuesday, March 9th, Commissioner Peters requested Administrator Burton research and compile data from counties with a mask mandate compared to counties without a mandate and submit a report for the next Board of Commissioner Meeting on April 13, 2021.

We the people of Pinellas County have reason to believe there is a prejudiced confirmation bias in the way data is presented to this Board, particularly regarding the State of Emergency and the Mask Mandate. We, all 73 Pinellas County residents who signed this letter, here by request that you have an independent third-party compile the data of the difference in the counties with and without a mask mandate and present that data to the commission at your April meeting. This third-party entity should not include Administrator Barry Burton or his office, Dr. Choe, Dr. Jameson, or anyone else who benefits monetarily, either individually or as a representative of an organization, from the State of Emergency funds since this Board has the Pinellas County Mask Mandate tied to the Pinellas County State of Emergency Order. This should be strictly an unbiased report of the facts and data that has been collected over the past year regarding the positivity rates, hospitalization rates, and death rates specifically from Covid-19, of counties with a mask mandate compared to counties without a mandate.
