

CONDITIONAL EXTENSION

THIS AGREEMENT, made and entered into this 27 day of ^{December} 2017, by and between PINELLAS COUNTY, a political subdivision of the State of Florida, hereinafter referred to as the "County" and The Greater Palm Harbor Area Chamber of Commerce, hereinafter referred to as the "Fund Recipient".

WITNESSETH:

WHEREAS, Pinellas County received funds through a settlement ("Settlement") with parties responsible for the Deepwater Horizon accident which affected the Gulf of Mexico and communities in the region including Pinellas County; and

WHEREAS, the Parties desire to extend the Funding Agreement; and

WHEREAS, all other terms and conditions of the Funding Agreement shall remain in full force and effect.

NOW, THEREFORE, the parties hereto do mutually agree as follows:

1. Extension of Services

The Parties hereby agree to extend the provision of services provided for in the Funding Agreement consistent with the terms and conditions found therein.

2. Receipt and Remittance of Funds

The Fund Recipient has received \$76,942.11 from the County as proceeds from a settlement negotiation and shall deposit this amount in an account to be used as follows:

- To provide capital improvements to the Greater Palm Harbor Area Chamber of Commerce by creating Palm Harbor Visitor's Center and providing community resources to be used by the Fund Recipient and community partners. Capital

improvement not to exceed \$63,680 and the event equipment not to exceed \$14,400. Items included listed below:

Capital Improvements

- Interior Improvements Painting
- Roof Modifications Deck
- Exterior Painting HVAC
- Building Sign Furniture
- Computers & Printers Scanner
- Phone System Copier
- Landscaping

Event Equipment

- Shed
- Golf Cart
- Event Signs

The remaining funds \$1,137.89 shall be used for the above proposes. All funding provided by the County may be paid upfront based on a written quote/estimate/purchase order for specific purchases. Recipient agrees to provide the County receipts for all purchases pertaining to the purpose of funding the extension of the Fund Agreement consistent with the terms set forth in the Funding Agreement.

3. Performance

Should at any time the contractor be unable to perform under the Fund Agreement or the Extension created hereby, all funds retained pursuant to this extension agreement shall be returned to the County.

4. Effective Date

This Conditional Extension shall take effect immediately upon execution by the parties hereto and expire on April 1, 2018.

5. Terms & Conditions

All other terms and conditions of the Fund Agreement shall remain in full force and effect.
