ZONING RESOLUTION **CHANGING** THE CLASSIFICATION APPROXIMATELY 2.79 ACRES LOCATED AT 13000 PARK BOULEVARD IN UNINCORPORATED SEMINOLE; PAGE 282 OF THE ZONING ATLAS, AS BEING IN SECTION 29, TOWNSHIP 30 SOUTH, RANGE 15 EAST; FROM R-E, RESIDENTIAL ESTATE TO RM-CO, MULTI-FAMILY RESIDENTIAL – CONDITIONAL OVERLAY WITH THE CONDITIONAL OVERLAY AND AN ASSOCIATED DEVELOPMENT AGREEMENT LIMITING THE NUMBER OF RESIDENTIAL DWELLING UNITS TO A MAXIMUM OF 20 THAT WILL INCLUDE A COMBINATION OF ONE AND TWO BEDROOM UNITS IN SINGLE STORY ATTACHED RESIDENTIAL STRUCTURES, TO BE OCCUPIED AS INDEPENDENT HOUSING FOR A MAXIMUM OF 24 PERSONS WITH DEVELOPMENTAL DISABILITIES, AS DEFINED BY FLORIDA STATUTE SECTION 393.063(1), WITH SUPPORTIVE HOUSING SERVICES OFFERED TO ONSITE RESIDENTS ONLY. THE EXISTING TWO-STORY STRUCTURE IS ALLOWED TO REMAIN. REQUIRED MINIMUM BUILDING SETBACKS SHALL BE 25 FEET FRONT, 15 FEET SIDES, AND 200 FEET REAR; UPON APPLICATION OF COMMUNITY ASSISTED & SUPPORTED LIVING, INC. THROUGH ANGELA RAUBER, ESQ, AND KATIE COLE, ESQ, HILL WARD HENDERSON, P.A., REPRESENTATIVES, ZON-23-03

WHEREAS, Community Assisted & Supported Living, Inc., owner of the property hereinafter described, has petitioned the Board of County Commissioners of Pinellas County to change the zone classification of the real property from R-E, Residential Estate to RM-CO, Multifamily Residential – Conditional Overlay with the Conditional Overlay and an associated Development Agreement limiting the number of residential dwelling units to a maximum of 20 that will include a combination of one and two bedroom units in single story attached residential structures, to be occupied as independent housing for a maximum of 24 Persons with Developmental Disabilities, as defined by Florida Statute Section 393.063(1), with supportive housing services offered to onsite residents only. The existing two-story structure is allowed to remain. Required minimum setbacks shall be 25 feet front, 15 feet sides, and 200 feet rear; and

WHEREAS, legal notice of public hearing on such proposed change of zone classification was duly published as required by law, as evidenced by publisher's affidavit filed with the Clerk; and

WHEREAS, said public hearing has been held on the date and at the time specified in said published notice at which citizens and interested persons have been given opportunity to be heard, and all requirements of law and of rules promulgated by this Board have been complied with; and

WHEREAS, this Board has determined that the zone classification of said property should be changed.

Now Therefore, Be it Resolved by the Board of County Commissioners of Pinellas County in regular session duly assembled this 31st day of October 2023, that the zone classification of the following described real property in Pinellas County, Florida, to wit:

be, and the same is hereby changed from R-E, Residential Estate to RM-CO, Multi-family Residential – Conditional Overlay with the Conditional Overlay and an associated Development Agreement limiting the number of residential dwelling units to a maximum of 20 that will include a combination of one and two bedroom units in single story attached residential structures, to be occupied as independent housing for a maximum of 24 Persons with Developmental Disabilities, as defined by Florida Statute Section 393.063(1), with supportive housing services offered to onsite residents only. The existing two-story structure is allowed to remain. Required minimum setbacks shall be 25 feet front, 15 feet sides, and 200 feet rear, Case Number ZON-23-03.
