Upgrading the toilets and fixtures will enhance the performance and efficiency, and most importantly, the equipment's hygiene, durability and maintenance will be improved.</p> <p>This facility sits at a community park that serves the public coming to use the playgrounds, picnic shelters, band shell and fishing pier. Our community facilities enhance the lives of residents in several ways. Green space provides a variety of health benefits by promoting physical activity, connection to nature, and opportunities for community engagement. Green space is at a minimum in the Palm Harbor area, therefore keeping them in top condition is a priority, but it is difficult because of limited budgets.
