WHEREAS, John Morroni, a member of the Pinellas County Board of County Commissioners, has passed away; and

WHEREAS, Article X, Section 3, of the Florida Constitution, and section 114.01(1)(b), Florida Statutes, provide that a vacancy in office shall occur upon the death of an incumbent public officer; and

WHEREAS, section 114.01(2), Florida Statutes, provides that the Governor shall file an Executive Order with the Secretary of State setting forth the facts giving rise to the vacancy in office.

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, by virtue of the authority vested in me by the Constitution and laws of the State of Florida, declare that due to the death of Commissioner John Morroni, a vacancy exists on the Pinellas County Board of County Commissioners, which shall be filled in compliance with the law.
