ORDINANCE NO. 18-32

AN ORDINANCE AMENDING THE FUTURE LAND USE MAP OF PINELLAS COUNTY, FLORIDA BY CHANGING THE LAND USE DESIGNATION OF APPROXIMATELY 0.67 ACRE LOCATED AT 1003 VIRGINIA AVENUE LOCATED IN SECTION 01, TOWNSHIP 28, RANGE 15 FROM RESIDENTIAL OFFICE GENERAL TO COMMERCIAL NEIGHBORHOOD; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the application for an amendment to the Future Land Use Map of Pinellas County, Florida, hereinafter listed, has been presented to the Board of County Commissioners of Pinellas County; and

WHEREAS, notice of public hearings and advertisements have been given as required by Florida Law; and

WHEREAS, the comments and recommendation of the Local Planning Agency have been received and considered; and

WHEREAS, this is a small scale development amendment, as defined by Section 163.3187(1), Florida Statutes.

NOW THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Pinellas County, Florida in regular meeting duly assembled this 21st day of August 2018 that:

Section 1. The Future Land Use Map of Pinellas County, Florida is amended by redesignating the property described as: Approximately 0.67 acre located at 1003 Virginia Avenue Referenced as Case Z/LU-14-07-18, and owned by Palm Harbor Florida, LLC, from Residential Office General to Commercial Neighborhood. Legal Description: SUTHERLAND, TOWN OF BLK 148, W 125FT OF S 150 FT & E 5FT OF W 130FT OF S 100FT AND PART VAC STR ON W DESC BEG SW COR SD BLK 148 TH N69D12'40"W 101.18FT TH N20D47'20"E 95.92FT TH NE'LY 26FT(S) TH E'LY 50FT TH S'LY 150FT TO POB PER O.R. 5190/1340 (SEE MAP 02-28-15).

Section 2. This amendment shall be transmitted to the Pinellas Planning Council for action to amend the Countywide Future Land Use Plan from Office to Retail & Services to maintain consistency with the said Plan.

Section 3. This Ordinance shall take effect upon:

- a) Receipt of notice from the Secretary of State that the Ordinance has been filed is received; and
- b) Approval by the Countywide Planning Authority of the requisite amendment of the Countywide Future Land Use Plan submitted herein pursuant to Chapter 2012-245, Laws of Florida.
- c) Pursuant to Section 163.3187(5)(c), Florida Statutes, this amendment shall become effective upon 31 days following its adoption. If timely challenged, this amendment shall not become effective until the state land planning agency or the Administration Commission issues a final order determining the adopted small scale amendment is in compliance. No development orders, development permits, or land uses dependent on this Amendment may be issued or commence before the amendment has become effective.
