FIRST AMENDMENT

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for Tank Wagon Delivery services at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- 1. "Addendum No. 4 Section F Bid Submittal and Summary" is hereby deleted in its entirety and replaced with the following revised price schedule attached herein as Exhibit A.
- 2. Line item 1 above increases the contract value in the amount of \$1,851,763.90 for a new revised not to exceed expenditure of \$13,019,556.70
- 3. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.
