| 4. <u>PLANNING TOPICS OF INTEREST</u> A. Forward Pinellas Complete Streets Applications | Chelsea Favero introduced the Forward Pinellas Complete Streets Grant Program and gave the four local governments who submitted applications an opportunity to present their projects to the PAC. <ul style="list-style-type: none"> - The City of Dunedin is requesting \$100,000 to develop a concept plan for Skinner Boulevard from U.S. Alternate 19 to Main Street. - The City of Largo is requesting \$1,000,000 in construction funding for Rosery Road between Missouri Avenue and Eagle Lake Park. - The City of Oldsmar is requesting \$1,000,000 in construction funding for St. Petersburg Drive from East Dartmouth Avenue to Bayview Boulevard. - The City of St. Petersburg is requesting \$60,000 in planning funding for the southern half of the South St. Petersburg Community Redevelopment Area (CRA), bounded by 49th Street S, 13th Avenue S, 3rd Street S, and 30th Avenue S. Volunteers for participation on the review committee were solicited from among the PAC | |

| <p>B. Socio-Economic Data Development for the 2045 Long Range Transportation Plan</p> | <p>Chelsea Favero gave an overview of what a long range transportation plan (LRTP) is, how local government plans help influence it and how the development of socioeconomic data projections is one of the first steps in the process. For the 2045 LRTP, Forward Pinellas and the MPOs of Hillsborough and Pasco county will be using a GIS tool called CommunityViz to help identify where future growth in population and employment will occur. Chelsea gave an overview of the tool and described how 'placetypes' form the basis for growth allocations. Each area of the county will need to be assigned a specific 'placetype' that adequately reflects the land use characteristics of that location. Chelsea described the various 'placetypes' recommended for use in Pinellas County and asked that PAC members review the attributes suggested for each 'placetype' and provide comments on those attributes within the next two weeks.</p> | |
| <p>C. "Peril of Flood" Requirements Update</p> | <p>Linda Fisher provided follow-up information from the Florida Department of Economic Opportunity (DEO), regarding local government responsibilities of the Peril of Flood Act, Section 163.3178(2)(f)1-6, Florida Statutes. Clarification on a couple of points:</p> <ul style="list-style-type: none"> - Requirements apply only to jurisdictions that must adopt a Coastal Management Element pursuant to Section 380.24, Florida Statutes. - Local governments are required to adopt applicable policies into their comprehensive plans during their EAR-based amendments. - A correction to the January meeting, local governments are <u>not</u> required to conduct vulnerability analysis, however DEO encourages local governments to do so. <p>Forward Pinellas will continue to coordinate with DEO and the Tampa Bay Regional Planning Council for changes and updates and bring them to the PAC membership.</p> | |
