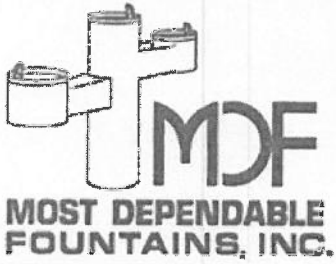
**EAST LAKE RECREATION MSTU REQUEST**
