#### Summary:

This lawsuit arises as a result of Plaintiffs', Corey Gourdine and Sakria Gourdine, allegations that on or about October 30, 2013, they were injured at or near the intersection of U.S. 19 and S.R. 580 due to negligently maintained traffic control devices. Mr. and Mrs. Gourdine were pedestrians standing in the median when a motor vehicle accident occurred in the intersection. One of the motor vehicles allegedly struck Mrs. Gourdine and then the traffic control device. The traffic control device was then dislodged from its base and allegedly struck Mr. Gourdine. Both individuals assert physical and mental injuries.

The road is owned by the Florida Department of Transportation (FDOT); however, Pinellas County is under contract with FDOT to maintain the traffic signals pursuant to the timing standards provided by FDOT. Pinellas County's records show the traffic signal at issue was properly maintained before and after the accident with no indication the signal was faulty during the timeframe at issue.

In addition to recommending rejection of this specific demand, this memo also seeks the Board's authorization for the County Attorney and Risk Manager to, upon their joint agreement, reject any further settlement demands without need for Board approval.
