**Summary:**

Claimant was hired by Pinellas County as an Electrical/Mechanical Technician at South Cross Bayou Waste Water Treatment Plant in August 2003. He is 60 years old.

On September 2, 2016, Claimant sustained a work-related injury to his right knee that required a total knee replacement. Pinellas County has paid for Claimant's treatment under workers' compensation, for a total of \$234,479.42 to date. Claimant has two additional open workers' compensation claims; one for suffering heat exhaustion on June 15, 2016, treatment cost is \$3,529.16 to date; and one in which the Claimant sustained a work-related injury to his left eye on January 28, 2016, for a total cost of \$236.18 to date. Both of these claims were paid by Pinellas County under workers' compensation. The Claimant has nine other closed workers' compensation claims paid by Pinellas County under workers' compensation, which total \$88,689.61.

As a result of his September 2, 2016 knee injury, Claimant has been unable to return to work and is receiving temporary partial disability benefits.

Risk, County Administration and County Attorney staff met and reached the conclusion to recommend that the Board of County Commissioners approve a negotiated settlement in the amount of \$130,000.00.

As part and parcel to the settlement, Claimant will execute a general release and agree to a washout (meaning Claimant will no longer be treated through workers' compensation) for his open workers' compensation claims and he also agreed to voluntarily resign from employment with Pinellas County, which became effective September 14, 2017.
