Date/Time/Comments: 04/05/2014 Roadway construction work. Plans confirmed that contractor must provide stamped project drawings. Professional liability requested due to this exposure. No large traffic poles, or masts to be installed. Reviewed prior contract 17-2134A (attached) that is similar in size and scope. Used same limits for consistency. Project partially Federally funded by Community development Block Grant. No insurance requirements for funding indicated.

NOTES: Work consists of Construction of Pine Street Sidewalk and Roadway Improvements from 130th Street (Wilcox Road) to approximately 625 feet north of 134th Street in an unincorporated area just south of the City of Largo. While, the project is composed of two distinct segments, the intent will be to construct both segments jointly.

The first segment proposes to reconstruct the roadway with the addition of new sidewalk and curb along the east side of Pine Street from 130th Street to 134th Street. The objectives for these improvements are to provide pedestrian safety and ADA improvements, sidewalk connectivity, and roadway safety enhancements. The adjacent and second segment of the project proposes to reconstruct the roadway pavement from 134th Street approximately 625 feet north to match the recent repaving project at the limits of the City of Largo.
