ALS FIRST RESPONDER SERVICES AGREEMENT AMENDMENT NO. 1

AGREEMENT made this 12 day of 12016 between, the CITY OF PINELLAS PARK, a Florida municipal corporation ("Contractor") and the PINELLAS COUNTY EMERGENCY MEDICAL SERVICES AUTHORITY, a special district ("Authority").

In consideration of the mutual benefits set forth below, the parties agree as follows:

- Contractor currently contracts with the Authority to provide Advanced Life Support (ALS) First Responder Services. The Contractor and the Authority are currently parties to a contract whereby the Contractor provides Advanced Life Support (ALS) First Responder Services for the Authority, which contract is referred to herein as the "Agreement."
- Except as is otherwise set out herein, Contractor and Authority agree that
 upon approval by the respective Boards of Contractor and Authority and
 upon signing this Amendment No. 1, all terms of the Agreement will remain
 in full force and effect.
- The Authority provided funding as provided in the Annual Compensation for FY14-15 listed as Appendix B attached hereto. Appendix B reflects changes to the characterization and funding of an EMS Administrative Coordinator position (40 hours per week) for FY15-16 and FY16-17 and a staff vehicle in FY16-17.
- 4. Contractor and Authority will endeavor to utilize the new EMS Administrative Coordinator position to establish a community outreach program in collaboration with the EMS Authority and the EMS Medical Director. Toward that goal, the Contractor will track the employee's hours by project or assignment and have the EMS Administrative Coordinator participate in community outreach efforts to the extent possible.
- The effective date for funding is March 1, 2016.
