"Absolute bill of sale, full warranties of title, and release of county lien". Resolution 95-286 section IV (C-2) clearly states; The county has been sold.

We now live in a Water District; A Non-County, (unelected) <sup>DESPO TIC</sup> Water District.

The "Non-Advalorem Water District levy" amounts to Direct taxation without representation. And is an unwarranted elevation of power, <sup>DECLARATION OF INDEPENDENCE</sup> "giving rise" <sup>ARTICLE 3 SECTION 2 U.S. CONSTITUTION</sup> to an unjust form of government.
