**Description & Comments**

This is for the approval of the Second Amendment to the Agreement with Playmore West, Inc. d/b/a Playmore Recreational Products and Services for Rehabilitation Services for playground removal and installation.

Through this amendment the agreement amount is increased by the amount of \$3,575,000.00, for a total amount not to exceed \$8,175,000.00. The Ft. DeSoto playground installation scope expands to include a playground at the East Beach site as well as the campground. Five playground locations were added: Dansville, Tierra Verde, Wall Springs, Eagle Lake, and Wilde Lands. The agreement end date of December 31<sup>st</sup>, 2026 remains unchanged.

The Park Playground Replacement- ADA/Inclusive project, 004171A, is budgeted in the Adopted FY26-FY31 CIP for \$4,172,000.00, funded by Local Infrastructure Sales Surtax (Penny for Pinellas) and the American Rescue Plan Act (ARPA).

\*ARPA projects with unspent allocations will be presented to the Board of County Commissioners on a future amendment reappropriating funding to other ARPA projects, such as Park Playground Replacement – ADA/Inclusive project, 004171A.
