



Good morning James,

Thanks for getting back to me. Advertisements for budget amendments (resolutions) follow a different set of guidelines per Florida Statute 129.06, and I wanted to confirm that those dates align with dates that we can advertise in the Tampa Bay Times. The guidelines per statute are as follows:

129.06

1. *The public hearing must be advertised at least 2 days, but not more than 5 days, before the date of the hearing. The advertisement must appear in a newspaper of paid general circulation and must identify the name of the taxing authority, the date, place, and time of the hearing, and the purpose of the hearing. The advertisement must also identify each budgetary fund to be amended, the source of the funds, the use of the funds, and the total amount of each fund's appropriations.*

If we can run an ad on any day, than I would prefer to run it on 8/11/17, that way if anything changes from the date of the ad running, we still have 3 days to re-run the ad and make changes. If we can run the ad on the 11th, how soon would you need to have the file to TBT so we can review a proof and make any necessary adjustments? In what format does TBT need the file? .doc, .rtf, .pdf?
