Chair Peters invited Mses. Dolan and Drake and Mr. Scofield to join her at the podium and read a proclamation recognizing May 2024 as National Historic Preservation Month.

Referring to a PowerPoint presentation, Ms. Boehmer provided a summary of the 2024 State Legislative Session. She discussed the state budget, bills that passed and failed, funding for various Pinellas County projects, and key legislative changes.

In response to queries by the members, Ms. Boehmer, with input from Mr. Moore, provided information regarding various deadlines, anticipated Special and Regular Sessions, the Unauthorized Public Camping and Sleeping bill, and the Vacation Rentals bill.

- 6. Fiscal Year Ended September 30, 2023 Annual Comprehensive Financial Report:
  - Ken Burke, Clerk of the Circuit Court and Comptroller
  - Jeff Wolf, Shareholder, MSL CPAs & Advisors

Mr. Burke emphasized the importance of transparency in financial reporting, noting the efforts of the Clerk's Office to make financial information accessible to the public via the Spending in the Sunshine website.

Referring to several County financial reports issued by the Clerk's Office for Fiscal Year 2023, including the Annual Comprehensive Financial Report, the Annual Financial Report, the Citizens' Guide to County Finances, and the Annual Debt Report, Mr. Burke indicated that the County received a clean audit and acknowledged the Finance Division's financial leadership team for their contributions. He provided information related to the County's investment income from the past fiscal year and the proposed internal loan policy, explaining that the policy will be presented to the Board in July; that it has undergone multiple rounds of review; and that it will serve the County in cases of emergency which require an immediate cash need.

Noting that the County transitioned to a new audit provider this year, Mr. Burke introduced Mr. Wolf and thanked him and his firm for their work in facilitating a seamless transition.

Referring to a PowerPoint presentation, Mr. Wolf provided an overview of various reports and other deliverables and discussed comparative data from similar counties. He indicated that an unmodified opinion, or clean audit, was issued for the Annual Comprehensive Financial Report; that no material weaknesses or significant deficiencies on internal controls and compliance were found; and that audits of the Constitutional Officers' offices were also clean; whereupon, he, with input from Mr. Burke, responded to comments and queries by the members.

Referring to Ms. Kirby's concerns regarding the cutting of trees by Duke Energy, Chair Peters indicated that Duke Energy is communicating with the County regarding a potential policy change.

Mr. Burton addressed Ms. Brown's concerns related to sinkholes, indicating that Public Works is aware of the issue; and that staff must work with homeowners to secure necessary construction easements to make repairs.

#### **BOARD OF COUNTY COMMISSIONERS**

8. Petition of James Kasper, as manager of Trustee Asset Services, LLC, a Florida Limited Liability Company, which serves as Trustee of the Hibiscus Land Trust, vacating the north 90 feet of a 30 foot right of way of Cocoanut Avenue, Lying East of Lot 1, Harbor View "A," Plat Book 9, Page 54, Lying in section 29-30-15, Pinellas County, Florida. (Legislative Hearing).

Item deferred to the July 16 meeting.

In response to a query by Commissioner Flowers, Building and Development Review Services Director Kevin McAndrew referred to a PowerPoint presentation and provided information regarding the petition, noting that no County departments or utilities providers have objections to the vacation; that, if granted, the petition would enable a larger side yard area and, ultimately, a larger home to be built on the property; and that staff recommends approval.

In response to queries by the members, Mr. McAndrew indicated that there is no revenue associated with the transfer of the title; and that the County has not invested money to improve the above-referenced area. Thereupon, responding to a query by Commissioner Scott, Attorney White provided clarifying information related to potential financial implications of the proposed vacation.

Upon the Chair's call for public comment, the following individuals appeared and expressed their concerns:

Responding to further queries by the members, Public Works Director Kelli Hammer Levy, with input from Mr. Burton, clarified that the County maintains the proposed area to be vacated through a general mowing cycle; whereupon, Attorney White indicated that the County may be liable for accidents on the right-of-way. The members provided suggestions and concerns regarding disposal of the land, and discussion ensued wherein Commissioners Long, Flowers, Latvala, and Justice indicated their support to allow staff more time to research the item.

A motion was made by Commissioner Latvala, seconded by Commissioner Flowers, that the item be deferred to the Board's July 16 meeting. The motion carried by the following vote:

## Public Works

22. National Flood Insurance Program Community Rating System Annual Report.

Report received and filed.

Responding to a query by Commissioner Eggers, Mr. Burton related that the State of Florida not only approves vulnerability assessments when completed, but also encourages them being done; and that the County receives grant funding from the state to conduct the assessment, which includes recommended adjustments to flood maps based on data related to storm impacts.

Referring to a document titled *Flood Insurance Rate Map (FIRM) Update for Pinellas County*, Public Works Director Kelli Hammer Levy compared base flood elevation changes from the 2003 FIRM to the 2021 FIRM, noting that 71% of the County has remained unchanged; and that the study focused on coastal areas only.

Ms. Levy reviewed the differences between the 2003 FIRM and the vulnerability assessment, relating that eligibility for state funding requires that vulnerability assessments are done; and that the data is also utilized for capital planning and local mitigation strategy; whereupon, with input from Mr. Burton, she responded to comments and queries by the members.

A motion was made by Commissioner Justice, seconded by Commissioner Flowers, that the item be approved. The motion carried by the following vote:

At the request of Commissioner Eggers, Public Works Director Kelli Hammer Levy provided background information regarding Fisher Road, noting that the County is updating the right-of-way map to complete an upcoming resurfacing project which will improve road conditions.

Grant funds in the amount of \$1,918,398.20 will be awarded on a cost reimbursement basis. No matching funds required.

In response to queries by Commissioner Scott, Department of Safety and Emergency Services Director Jim Fogarty, with input by Mr. Burton, indicated that the grant application is subject to approval by the state; and that annual maintenance costs for the Vesta E911 phone system have been allocated in the existing contract and will not require additional funds.

Attorney White indicated that outside counsel who represents the County in various opioid epidemic-related lawsuits advised the County Attorney's Office (CAO) to join a lawsuit against pharmacy benefit managers; and that, absent opposition from the Board, the CAO will move forward with filing the lawsuit; whereupon, in response to a query by Commissioner Eggers, she clarified that pharmacy benefit managers are large corporations, not individuals.

In response to a query by Chair Peters regarding a need for a consensus, Attorney White clarified that the intent was to inform the Board; and that if there was any opposition, the CAO would have stepped back and regrouped.
