## ORDER GRANTING MOTION TO INITIATE DEMOLITION

Devol, Special Magistrate Officer of Pinellas County Code Enforcement Division appeared as a witness. Ronald Shutt, brother of deceased owner, on behalf of Respondent(s), Richard E Potter Est, did appear. Being fully advised on the premise, It is hereby ORDERED that Petitioner's Motion to Initiate Demolition is hereby GRANTED.

If the Pinellas County Housing Official determines that the property is unsafe and unfit for human habitation, the property may be condemned. Pursuant to Section(s) 22-278 through 22-280, if the property is deemed an extreme hazard, the Housing Official may take or require immediate corrective action. The terminology "to correct" includes, but is not limited to, action taken to alter, upgrade, secure, repair, remodel or demolish any unsafe building. The costs incurred shall be charged to the owner and shall constitute a lien upon the property and shall be collected in the manner provided by law.

**Appeals:** Any aggrieved party may appeal this order to the Circuit Court. An appeal must be filed within thirty (30) days of the execution of this order.
