

**FIRST AMENDMENT TO THE INTERLOCAL AGREEMENT WITH THE SIXTH  
JUDICIAL CIRCUIT PUBLIC DEFENDER FOR THE CRIMINAL JUSTICE MENTAL  
HEALTH AND SUBSTANCE ABUSE REINVESTMENT GRANT**

**THIS AMENDMENT** is made and entered into this 22nd day of October, 2020, by and between PINELLAS COUNTY, a political subdivision of the State of Florida, **hereinafter referred to as the "COUNTY"**, and BOB DILLINGER, PUBLIC DEFENDER FOR THE SIXTH JUDICIAL CIRCUIT, an independent constitutional officer for Pinellas County, **hereinafter referred to as "PD."**

**WITNESSETH:**

**WHEREAS**, the COUNTY in collaboration with PD and Ready for Life, Inc. was awarded the 2019 Criminal Justice, Mental Health, and Substance Abuse Reinvestment Grant, hereinafter "CJMHS A Grant," by the Department of Children and Families; and

**WHEREAS**, the COUNTY, in response to the collaborative application with PD and Ready for Life, Inc., has entered into a Client Services Agreement with the Department of Children and Families; and

**WHEREAS**, the CJMHS A Grant funds the Pinellas County Road to Success Project, which is an expansion of the PD's existing crossover youth program; and

**WHEREAS**, the COUNTY, as the grantee of the CJMHS A Grant, is acting as the fiscal agent; and

**WHEREAS**, on June 23, 2020 the COUNTY and PD entered into an Interlocal Agreement, effective July 1, 2020, to facilitate activities under the CJMHS A Grant; and

**WHEREAS**, COUNTY and PD find it necessary to amend the Agreement to allow for monthly reimbursement; and

**WHEREAS**, PD has provided and continues to provide services consistent with the requirements of the grant;

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements hereinafter contained, it is agreed by and between the parties hereto as follows:

1. The above WHEREAS statements are incorporated into and made a part of this Agreement.

2. Section 3 b) of the Agreement, is amended to read as follows:

b) The PD shall provide the COUNTY with the monthly or quarterly value of matching funds along with financial record and reports required to track match funds and process and submit invoices in compliance with Section C-2 of Exhibit 2.

3. All other terms and conditions of the Agreement shall remain in full force and effect.
