NOTICE OF PUBLIC HEARING PROPOSED ORDINANCE AMENDING THE PINELLAS COUNTY CODE

The Pinellas County Board of County Commissioners proposes to amend the Pinellas County Code by Ordinance.

A public hearing on the Ordinance will be held on Tuesday January 28, 2025 at 6:00 P.M. in the Pinellas County Communications – Palm Room, 333 Chestnut Street, Clearwater, Florida 33756.

Interested parties may appear at the hearing and be heard regarding the proposed Ordinance.

1. PROPOSED ORDINANCE TO AMEND THE PINELLAS COUNTY CODE:

AN ORDINANCE OF THE COUNTY OF PINELLAS RELATING TO DUNE PROTECTION; PROHIBITING TRAVERSING ACROSS OR MODIFYING DUNES WITH EXCEPTIONS; PROHIBITING ACTIVITY ON DUNES WITHOUT A REQUIRED STATE COASTAL CONSTRUCTION CONTROL LINE PERMIT; PROVIDING FOR APPLICABILITY ON BARRIER ISLANDS COUNTYWIDE; PROVIDING FOR ENFORCEMENT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.
