Summary:

Claimant was hired by Pinellas County on October 9, 1991, and currently holds the title of Craftworker, Detention Services/Real Estate Management. On December 18, 2002, he injured his lower back moving file cabinets at work. Pinellas County has paid for Claimant's treatment under workers' compensation, the cost of which totals \$191,267.14 to date.

Since 1993, Claimant has reported 23 work-related incidents involving injury. The County has expended \$253,122.72 to date for all 23 incidents combined.

Claimant was referred to a fitness for duty exam on April 25, 2016, and was found to be fit for duty on April 28, 2016. Subsequent thereto, he was hospitalized for unknown reasons. Claimant returned to full-duty employment on June 12, 2016.

On May 10, 2016, Claimant filed a Petition for Benefits seeking total disability benefits during the time he was out of work.

Claimant made an initial offer of \$125,000.00 for a washout settlement of this claim, meaning that Pinellas County would no longer provide medical or indemnity benefits in connection with his December 18, 2002 accident.

Claimant is 64 years old, and therefore Medicare eligible within the next 30 months. Because the County may not shift the burden of payment for a workers' compensation covered injury to Medicare, a Medicare Set-Aside (MSA) was obtained. Pursuant to the MSA, it is recommended that \$33,433.11 be allocated for annuity seed money.

As part and parcel to this negotiated settlement, Plaintiff will voluntarily resign from employment with Pinellas County; execute a general release of all claims against Pinellas County; dismiss the Petition for Benefits; agree to the proposed washout of the December 18, 2002 claim; and agree to allocate \$33,433.11 of the settlement funds to an annuity.

Risk, County Administration and County Attorney staff met and reached the conclusion to recommend that the Board of County Commissioners accept this settlement in the amount of \$80,000.00.
