TOTAL PROJECT COST: \$74,930.87 PAYMENT TERMS: 40/30/30

(\$29,972.35/40%) Down payment for development of submittals, manufacturing of netting, poles, and mobilization. (\$22,479.26/30%) Upon crew arrival. (\$22,479.26/30%) Upon substantial completion of Work, and acceptance of work/sign off.

PROJECT SCHEDULE: We estimate 1 week (7 days) to completion from the time our crew arrives if weather and ground conditions permit.

TERMS AND CONDITIONS

- 1. This document constitutes an offer for the construction and installation of a barrier netting system, utilizing the specified materials, as outlined in the preceding section (Page 4). The total project cost (SUM) is subject to modification based on the final engineered drawings provided by a certified professional engineer, fluctuations in supply and demand at the time of contract execution, and any subsequent changes in material orders, as well as any delays or disruptions caused by inclement weather or other unforeseen circumstances beyond our control, which may impact the procurement, production, milling, or transportation of raw materials.
- 2. Your responsibility as the customer is to have any private utilities located before our arrival and commencement of any drilling. Gorilla Netting will order public utilities located. If our crews encounter unforeseen ground conditions not typical to the area that was not reported (i.e., buried wood, concrete, debris, old foundation, pilings, etc.), it may require additional equipment, as well as additional crew and labor, which will result in additional charges above the quoted amount enclosed and will be billed accordingly.
- 3. Gorilla Netting crews must have full access to the work site area where work is being performed and where materials and equipment are being stored.
- 4. Any concrete, wood structures, irrigation of any kind, lighting, etc., that are not included in your structure design must be removed before work commences. Although we use the utmost care while on your property, Gorilla Netting is not responsible for damaged landscape, grass, concrete, irrigation, or lighting that has not been removed or protected.
- 5. You are responsible for removing anything that will obstruct work in the immediate project area (i.e., foliage, trees, overhanging branches, lighting, etc.)
- 6. Any costs due to delays in our work caused by site conditions or work by other contractors will be passed along to the owner plus 10%.
- 7. Any costs for permitting, expediting, licensing, etc., will be passed along to the owner.
- 8. Any responsibility for ball containment, height, and placement of netting is solely the customer's decision.
