## **Description & Comments**

This item is for the approval and execution by the County Administrator of a Termination Agreement between Pinellas County and Sunshine Properties, LLP relating to the original Employment Sites Program Grant Funding Agreement

The original agreement was brought before the Board of County Commissoners for conditional approval on September 22, 2022 in the amount of \$405,275.00 to cover stormwater work, and a fire sprinkler system in the new building to meet code requirements (Granicus Item 22-1498A). The agreement was brought before the board again on September 19, 2023 for the approval and execution of the agreement with Sunshine Properties, LLP (Granicus Item 23-0393D). This item is for the termination of the agreement at the request of Sunshine Properties, LLP. At the time of the requested termination, one payment in the amount of \$135,090.00 had already been issued to Sunshine Properties, LLP. Since then, Sunshine Properties, LLP has repaid the County a full repayment of \$135,090.00. Approval of the termination of this agreement will decrease the total amount of Penny IV Economic Development funds committed to \$46,774,694.00 out of the \$93,382,000.00 currently estimated in all ten years of Penny IV.

\*Funding for this project was included in the FY25-FY30 Capital Improvement Program plan under the Economic Development Capital Projects (project 004149A). This project was funded by Local Infrastructure Sales Surtax (Penny for Pinellas), as part of the 8.3% countywide investment for Economic Development and Housing, half of which, or 4.15%, is set aside for Economic Capital Projects specifically.

The Economic Development Capital Projects (project 004149A) has an Amended Fiscal Year 2025 Budget of \$25,183,000.00. FY25 Expenditures are estimated at \$19,266,322.00.

Total available funding is the amount of the full project allocation as represented in the approved budget. Available funding in excess of the recommended not-to-exceed amount is available for other project costs.

There is sufficient funding to approve this funding request. Attached to the Granicus item is a tracking document that shows the FY25-FY30 Budget, as well as all expenditure activity, both historical and planned. .
