EXPLANATION:

At the request of the Sheriff's Office, this amendment realigns appropriation from the General Government Non-Program cost center to the Pinellas County Sheriff's Office (PCSO) cost center within the General Fund. On March 18, 2016, House Bill 5005 was signed into law. This Bill establishes the Florida Retirement System employer contribution rates for the 2016-2017 plan years, which is based on the State of Florida's fiscal year that begins on July 1st. The Special Risk category attributable to the Sheriff's sworn personnel increased from 22.04% to 22.57%. The contribution rates for the non-sworn personnel increased from 7.26% to 7.52%. Appropriation is available in the General Fund Reserve for Contingencies. This amendment is not consistent with the FY16 projections provided during the FY17 budget development process.
