Comments: 12/28/20 establish a contract for supply of reclaimed and virgin methanol and 70% Glycerin Solution. Virgin Methanol or Reclaimed Methanol are acceptable products for this contract provided the technical requirements for either product is met. Reviewed ITB, Service Agreement and prior review under 16-799A. Contacted PM with questions regarding Glycerin, Certification and number of deliveries. Confirmed that Glycerin does not pose any additional health concerns; that tanks are located in a secondary containment so any spills would be contained; detection of mispresented content could alter the biofilm in the dentification filters, but would be detected pretty quickly; and there are a minimum of 52 deliveries per year. Attached PM's email response. Assigned same limits using Excess as prior review. Insurance Certificate on file has met these requirements. Risk high and limits reflect this.

Notes: 70% Glycerin Solution based supplemental carbon products shall be manufactured to meet the most stringent product specifications. Furthermore, to achieve consistent product quality, all Glycerin used in the production of a 70% Glycerin Solution based supplemental carbon shall originate from BQ-9000 certified producers. Adherence to the recommended product specifications is critical to ensure consistent denitrification performance for projects with very stringent effluent quality requirements. The manufacturer shall furnish an affidavit attesting that the supplied product complies with all applicable specifications referenced herein. Signature of affidavit of compliance required on Section F - Bid Summary Page.
