The Pinellas County Board of County Commissioners proposes to adopt the following Resolution amending the Pinellas County Zoning Atlas and Ordinances amending the Pinellas County Land Development Code.

A public hearing on the Resolution and Ordinances with virtual public participation and an on-site participation option, to be held on Tuesday, August 15, 2023, at 8:00 P.M. or thereafter in the County Commission Assembly Room, Fifth Floor, Pinellas County Courthouse, 315 Court Street, Clearwater, Florida 33756, with virtual participation utilizing Communications Media Technology (CMT) on the Zoom platform.
