

## Comprehensive Plan Update Policy Comparison

The following tables outline where PLANPinellas (comprehensive plan update) addresses the existing 2008 Comprehensive Plan (2008 Plan) policies. While the specifics may be different in the new policies, it indicates where the concepts are addressed. Some comments may be provided if there are noteworthy shifts in policy.

**Please note** that if a policy (or details of a policy) from the 2008 Plan is no longer addressed, it does not mean that it can longer be a chosen effort or strategy. Many of the old policies are more appropriate to be addressed as part of the decision-making process for County programs or action plans but does not necessarily rise to the level of policy in the Comprehensive Plan.
