**Benefit Summary (How will this benefit the County, Dept, etc?):** JAG projects and funding recommendations made by the Substance Abuse Advisory Board (SAAB), comprised of local community leaders in the justice system, law enforcement, and mental health

programs. The SAAB historically funds several community projects that improve the criminal justice system and reduce recidivism.

Each grant is given a separate project number in OPUS. All the awards were recommended by the SAAB at their October 12, 2017, meeting and will be presented to the Board of County Commissioner's for approval. All but two programs (St. Petersburg and Clearwater) are continuation funding from previous years.
