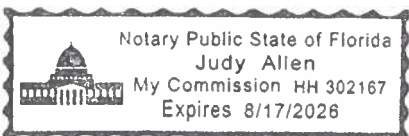

# NOTICE OF PUBLIC HEARING

The Pinellas County Board of County Commissioners will conduct a public hearing on proposed amendments to the FY2024 Budget as required by Section 129.06 (2), Florida Statutes, relating to the appropriation of unanticipated fund balance and unanticipated revenue as specified herein.

A public hearing on amending the budget will be held on Tuesday, July 16th at 9:30 a.m. in the Palm Room, 333 Chestnut Street, Clearwater, Florida 33756. The proposed amendments are as follows:

The unanticipated revenues will be appropriated to support the Pinellas County Mental Health Court; and to support the Parks and Natural Resources programs, salaries, and/or operating expenses.

The General Fund Reserves are also being reduced to provide funds to the Sheriff's budget to fund a one-time capital request for a Family Reunification Center plan.

The Tourist Development Tax Fund is also being amended to realign reserves to operating expenses for the support of aid to private organizations.

Interested parties may appear at the hearing and be heard regarding amending the budget.

Persons are advised that if they decide to appeal any decision made at the meeting/hearing, they will need a record of the proceedings, and, for such purposes, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
