FIRST AMENDMENT

This Amendment made and entered into this ______8 day of _____March_____, 2023, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Stryker Sales LLC, 2825 Airview Blvd, Kalamazoo, MI 49002 hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on July, 19th, 2022, pursuant to Pinellas County Contract No. 22-0369-N Stryker Medical; (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Hydraulic Stretchers for County; and

WHEREAS, Section thirty-seven ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for a contract extension and an increase to the contract expenditure for additional goods and services, at the same, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- Section 14 ("Compensation and Method of Payment"), subsection B, is revised to reflect an increase in the amount of three hundred fifteen thousand one hundred seventy-eight dollars, and zero cents (\$315,178.00) to the existing contract amount of \$284,088.08 for a new not to exceed total contract expenditure of \$599,266.08.
- The Parties agree to exercise the first term extension in accordance with Section 4 ("Term
 of Agreement"), subsection B ("Term Extension"), and hereby extend the term of the
 Agreement for an additional twenty –four (24) months.
- 3. Exhibit A is revised to incorporate the attached Quote 10586536 to the Agreement
- Except as changed or modified herein, all provisions and conditions of the original
 Agreement and any amendments thereto shall remain in full force and effect.
