**EMERGENCY MEDICAL SERVICES
ALS FIRST RESPONDER AGREEMENT
AMENDMENT NO. 2**

THIS SECOND AMENDMENT made this 9 day of September 2021 between the PALM HARBOR SPECIAL FIRE CONTROL & RESCUE DISTRICT, an Independent special fire district ("Contractor") and the PINELLAS COUNTY EMERGENCY MEDICAL SERVICES AUTHORITY, a special district ("Authority").

In consideration of the mutual benefits set forth below, the parties agree as follows:

1. Contractor currently contracts with the Authority to provide Advanced Life Support (ALS) First Responder Services. The Contractor and the Authority are currently parties to the Emergency Medical Services ALS First Responder Agreement, dated September 24, 2019, which contract is referred to herein as the "Agreement."
2. The Contractor's funding for FY20-21 totaled \$2,900,673 and the FY21-22 budget request is \$3,204,060. The cost increase is \$303,387 or 10.46%. The full budget increase of \$303,387 includes \$80,597 in allowable costs and \$222,790 to partially implement the position for Engine 65. Appendix A reflects changes to the characterization and funding for Engine 65.
3. The Authority hereby agrees to and has funded and authorized the Contractor's budget request of \$3,204,060 for FY21-22, which change is reflected on Appendix A hereto.

4. Except as is otherwise set out herein, the Contractor and the Authority agree that upon approval by the respective Boards of the Contractor and the Authority and upon signing this Amendment, all terms of the Agreement will remain in full force and effect.

5. Contractor and Authority agree that the effective date is October 1, 2021.


