PINELLAS COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT – DISASTER RECOVERY (CDBG-DR) CITIZENS PARTICIPATION PLAN

Pinellas County has developed a Citizen Participation Plan in compliance with the following regulations and Federal Register Notices (FRNs) for the Community Development Block Grant – Disaster Recovery (CDBG-DR) grant funds awarded to the County in response to Hurricanes Idalia, Helene, and Milton that occurred in 2023 and 2024:

- Federal Register Notice 90 FR 1754, January 8, 2025 (The Universal Notice), as amended March 19, 2025, at FR-6489-N-01 and in subsequent revisions issued by HUD
- Federal Register Notice 90 FR 4759, January 16, 2025 (Allocation Notice)
- 24 CFR 91.105 Citizen Participation Plan; Local Governments

The purpose of the Citizen Participation Plan (CPP), pursuant to above referenced FRNs, is to set forth the policies and procedures for citizen participation in the development of the Pinellas County CDBG-DR Action Plan and any substantial amendments. The CPP is intended to provide an effective means of involvement in all phases of Pinellas County's CDBG-DR Action Plan process by an informed citizenry.

The CPP provides a streamlined process and ensures disaster recovery grants are awarded in a timely manner. Provisions of 42 U.S.C. 5304(a)(2) and (3), 42 U.S.C. 12707, 24 CFR 570.486, 24 CFR 1003.604, 24 CFR 91.105(b) through (d), with respect to citizen participation requirements, are waived and replaced by alternative requirements in The Universal Notice.
