County Commissioner Meeting

My name is Barbara McNeill and I am here today to discuss my road on 46th Avenue north from 49th Street to 55 Street. I am a homeowner and been paying taxes for 50 years in Pinellas County. I have waited years to get sidewalks. I have gone to meetings over the last 10 to 15 years and spoken with project managers, Lealman Extension, person in charge of traffic and the sheriff depart for years. We continually been put off because of numerous reason. The road has been surveyed and new water mains have been put in place. East of us has been done and West of Kenneth City has done theirs. We are the middle section that has been left undone. Our road has been patched over and over again, double lines are faded and reflectors are missing. Where we are now is the estimates are too high and been resubmitted to contractors. I feel you have waited to long to take care of this project!

We also need a 4 way stop at 52 Street and 46th Avenue North. But I have been told that 46th Ave No is a collector road and nothing can be done to put a 4 way stop there. Right now there is a 2 way stop. No one goes the speed limit and they are passing on double lines. There has been several accidents. Children are walking to Westgate Elementary and Dixie Hollins High School. This is a very dangerous situation. Let's get out children out of danger! We need this taken care of ASAP.

The proposal is:

Pinellas County Type "A" curb & gutter on both sides of the road

5 Foot side Walks on the South side of the road

8 foot multi use path on the North side of the road

Upgrade drainage and sanitary sewer Facilities


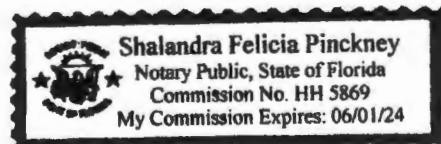
Dear Pinellas County Commissioner,
