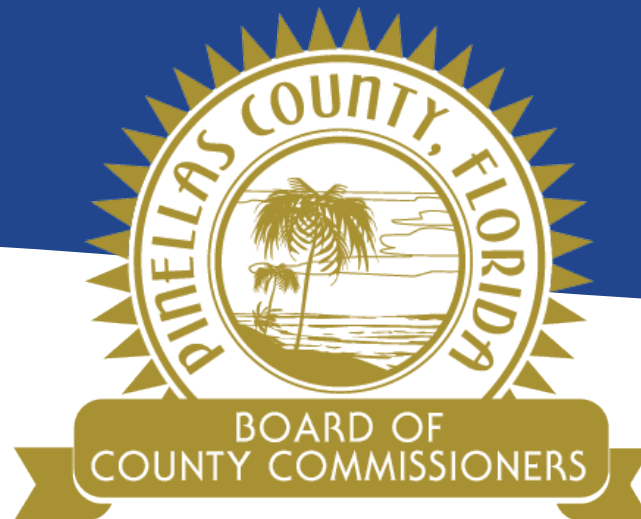

Project Goal

- **Replacement for the current North County Service Center located at 29582 US HWY 19 North**
- **Current Building was built in 1978 and no longer meets intended operational requirements, is too small and not efficient for citizens to use.**
- **The new North County Service Center will provide administrative offices for the Tax Collector, Property Appraiser and Clerk of Court in one location, eliminating leased space just to the South-East on US HWY 19.**
- **The New North County Service Center will save \$800,000 in leasing expenses annually for space currently occupied by the Tax Collector and Property Appraiser.**
- **The existing North County Service Center will be demolished and replaced with the new North County Service Center providing ample space for many years to come. The existing driving range for the Tax Collector and existing Solid Waste Recovery Center will remain.**

Project Goal Continued



- **A new three-story office building will be completed with a central lobby concept to meet the customer service requirements for greeting the public and security. The three Constitutional agencies will have the ability to have individual administrative spaces and to share support spaces.**
- **A new two-story parking garage is required for this site for county vehicles, staff vehicles and customer vehicles to meet the parking count analysis and level of service.**
- **Public parking for all public visitors is provided by both surface parking and the new garage.**
- **To meet State Guidelines and maintain Pinellas County's goals of conservation, the project will be designed to meet or exceed the United States Green Building Council's LEED Certification standards. This will include designing and building for energy conservation, water efficiency, and indoor environmental quality among other environmental and health concerns**

Additional components of site:

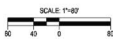
- Demolition of the 19,000 SF Existing NCSC and Adjacent 1,840 SF Operations Storage Building.
- New Pavement, Landscape, and Irrigation for 5 Acres of the 10 Acre site
- 28 New Surface Parking Spaces.
- New Retention Areas.
- Easement or Set Back Area for Future State DOT Pedestrian Overpass Crossing & Bridge at U.S.19.
- LEED design factored into construction

Total Estimated Construction Cost: \$34,500,000



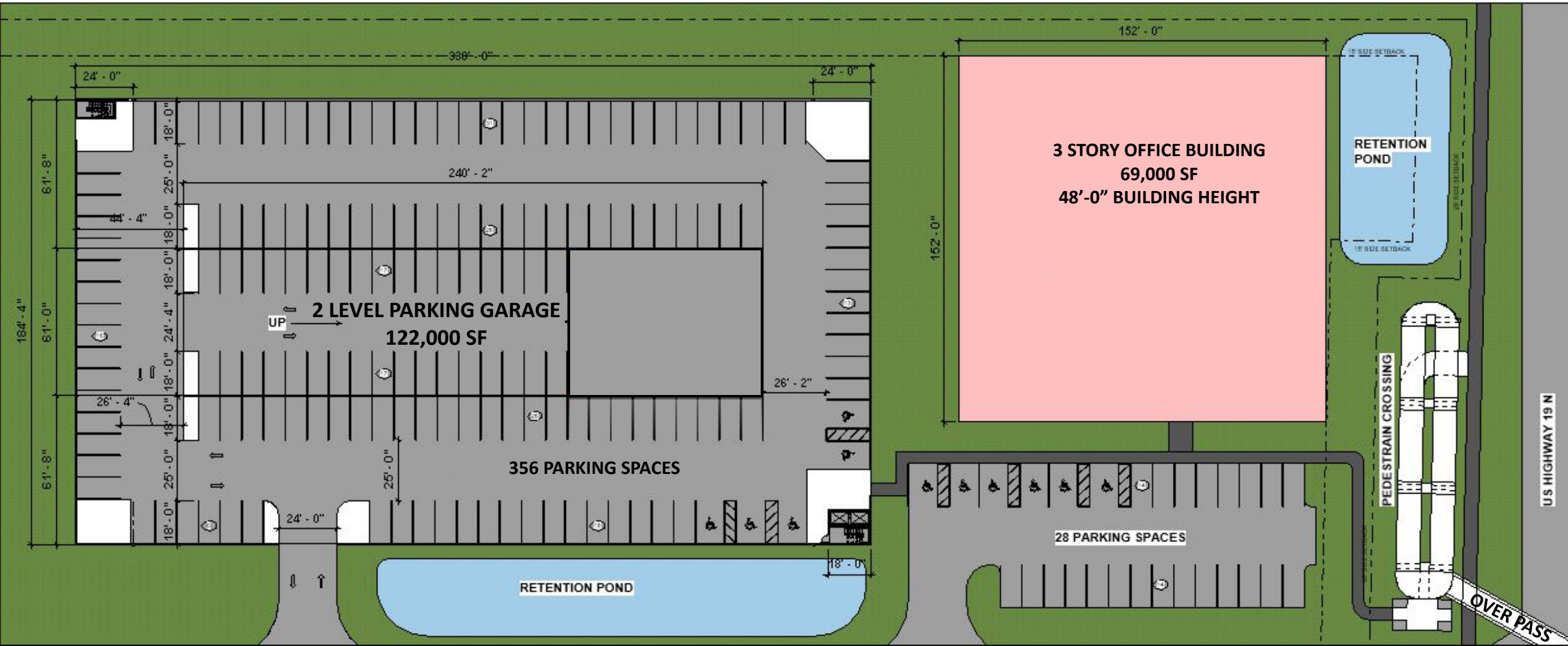

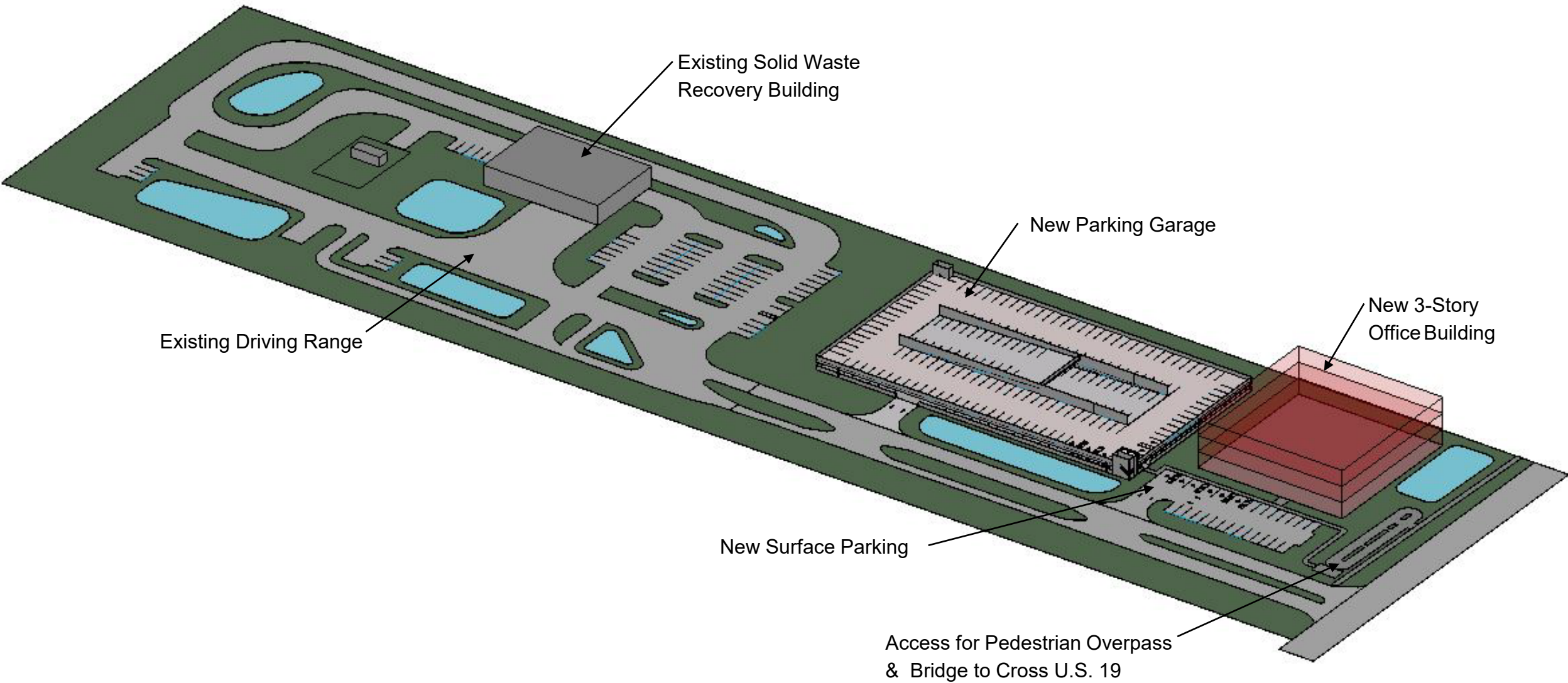
