# **Summary:**

This is a settlement of a workers' compensation claim based on injuries sustained during the course of employment on February 19, 2003. The Petitioner's injuries were previously deemed compensable. Claimant has agreed to the settlement. If settlement is approved, Claimant will no longer be entitled to benefits under workers' compensation.

Payment of this settlement will be largely covered by the excess insurance coverage. The County and Johns Eastern, Third-Party Administrator for worker's compensation calculate that less than \$60,000 will be paid through Risk Management, after the carrier reimburses the County for payment in excess of the primary self-insured retention.

The excess insurance carrier has authorized settlement of this. Approval of the settlement is recommended by the Sheriff, Johns Eastern, Third-Party Administrator, Risk Management, and the County Attorney' office.
