The Department of Environmental Protection has reviewed the local limits re-evaluation for the above-referenced Industrial Pretreatment Program (IPP) received on February 26, 2019. The proposed local limits appear to be technically defensible and are approved.

The approved local limits for both South Cross Bayou AWWTF (FL0040436) and William E. Dunn WRF (FL0128775) are provided in Attachment A and Attachment B, respectively. Since the modification to the County's local limits results in neither a less stringent limitation nor a need to modify the County's sewer use ordinance, a substantial program modification will not be required. Please implement the changes as provided in the County's proposed and approved local limits.
