**Summary:**

On March 20, 2019, Plaintiff Janet Flanagan filed a civil action against Pinellas County for negligence after Ms. Flanagan allegedly tripped and fell as the result of a broken water meter in a friend's driveway on April 4, 2018.

On December 17, 2019, a Proposal for Settlement was filed on behalf of the Plaintiff. The amount requested in the proposal was \$75,000.00, inclusive of all interest, costs and claims for attorney's fees. Evidence gathered to date does not support settlement in the amount claimed by Plaintiff. No trial dates have been set as discovery is still ongoing.

It is recommended that the proposed \$75,000.00 settlement be rejected. Risk Management and County Administration concur with this recommendation.
