The services are funded by a .70 mill tax assessed annually on property within the municipal services taxing district and shown with other taxes on annual property tax notices.</p>

(Required)	<p>Need/Gap: There are no opportunities to play Pickleball in the Feather Sound area.</p> <p>The applicant (Feather Sound Community Services District) is building two Pickleball Courts in the Earl Maize Recreation Area. The park currently features a playground with play structures, basketball court, multi-purpose recreational open space, a nature boardwalk, and two picnic pavilions.</p>

Design is underway and the project will be submitted to the County for site plan approval and related permits in Summer 24. Construction will begin late Summer/early Fall. The anticipated opening of the Pickleball Courts is late 2024 or early 2025.
