


PINELLAS COUNTY MAP





LAND SURVEYOR REPORT:

- Type of Survey: Boundary Survey
- Field work completed on March 7, 2025 as recorded in Cumbey & Fair Miscellaneous Field Book 123.
- Coordinates, distances, and elevations used in this survey are in US Survey Feet.
- Bearings and coordinate values shown hereon are based on the Florida State Plane Coordinate System, West Zone, North American Datum of 1983 (2011 Adjustment). Horizontal Coordinate values were obtained using Florida Department of Transportation (FDOT) Florida Permanent Reference Network (FPRN), deriving a Basis of Bearing of S 00°01'31" W on the West line of the NW 1/4 of Section 9, Township 30 S, Range 16 E.
- Topographic features were not located unless a specific encroachment was discovered.
- Title commitment supplied by American Government Services Corporation. File Number 33494. Effective date February 6, 2025. Exceptions #1, #2, #5, #7-9 and #14 are not survey matters.
- Pursuant to Florida Standards of Practice 5j-17.051 the above methodology for the horizontal coordinate values has produced a horizontal accuracy to two hundredths of a foot.



