		<ul style="list-style-type: none">· Pinellas County Human Services administered a competitive, online grant application process for FY21 Social Action Grant Funding.· The grant solicitation was posted on April 1, 2020, and a standard application form was used to promote effective review and scoring.· An amount not to exceed \$1,551,000.00 in funding is available, and agencies were eligible to request between \$10,000.00 and \$250,000.00.· Seventy-three applications were received, and a Social Action Grant Selection Committee recommended awards for 15 agencies.· Due to the large number of applications and a desire to reach all priority areas, the selection committee recommended partial funding for the highest scoring organizations requesting \$100,000.00 or more, and full funding for the highest scoring organizations requesting less than \$100,000.00, until the funding was exhausted.
