The parties agree that the Agreement is to be amended and supplemented as follows:

The Florida Shared-Use Nonmotorized Trail Network Agreement funding amount is increased to match the negotiated Guaranteed Maximum Proposal.

The expiration date of the Agreement is hereby extended to December 31, 2022.

Reason for this Supplemental and supporting engineering and/or cost analysis:

This Supplemental Agreement is to increase the funding amount to match the increased construction, consultant and material cost.

Total Construction & CEI cost \$13,339,868

FDOT Participation \$6,200,000

FDOT Non-Participating(Local Funds) \$7,139,868

Pinellas County will notify the Department of any Change Orders whether or not the Department is participating in them. Change order will not be implemented until the Department has granted approval.
