This item is for the award of bid to Preferred Materials for Fiscal Year 2026 Pavement Preservation - Package 1.

This agreement is for milling and resurfacing, pavement marking, detector loops, and traffic control for the stated Pinellas County resurfacing projects.

A total of four bids were received from the following bidders: Preferred Materials (\$4,542,974.00), Hubbard Construction Company (\$4,909,741.6019), Ajax Paving Industries of Florida, LLC (\$5,329,482.10), and SUPERIOR ASPHALT, INC. (\$5,435,001.004). Recommended award is to the lowest and most responsive bidder, Preferred Materials.

The agreement with Preferred Materials is for the following identified projects and items: Keene Rd Resurfacing project 006576A (\$1,136,490.94), Local Group 55 Resurfacing project 006240A (\$773,195.00), Local Group 101 Resurfacing project 006300A (\$681,084.44), Local Group 135 Resurfacing project 006310A (\$666,424.51), Local Group 142 Resurfacing project 006231A (\$758,779.11), water items (\$2,000.00), sanitary sewer items (\$10,000.00), and unspecified items (\$515,000.00).

This agreement is for a not to exceed amount of \$4,542,974.00 and a contract duration of 210 consecutive calendar days. Work will commence after a Notice to Proceed (NTP) has been issued by the County.

Funding for subprojects, Keene Rd Resurfacing project 006576A, Local Group 55 Resurfacing project 006240A, Local Group 101 Resurfacing project 006300A, Local Group 135 Resurfacing project 006310A, and Local Group 142 Resurfacing project 006231A, is reflected in the Amended FY25 Capital Budget, budgeted under the Road Resurfacing & Rehabilitation PIV project 004192A funded by the Penny for Pinellas and the Transportation Millage Capital Resurfacing Program project 005700A funded by the Transportation Millage. Available funding in excess of the recommended not-to-exceed amount is available for other project costs. In the event that future fiscal year funding is not available for this project, the County maintains the authority to terminate this agreement.
