**JOINT PARTICIPATION AGREEMENT
Amendment No. 1**

This Amendment, entered into on this 11 day of ^{June} , 2020, by and between the STATE OF FLORIDA, DEPARTMENT OF TRANSPORTATION (the "DEPARTMENT"), and Pinellas County (the "COUNTY").

WITNESSETH:

WHEREAS, the parties have been granted specific legislative authority to enter into this Agreement pursuant to Section 334.044(7) and 339.12(5), Florida Statutes; and

WHEREAS, the COUNTY agrees to construct and install drainage outfall pipes on US 19/SR 55 from Pinellas Co. Govt Ent to N of Pinellas Co. Govt Ent (PROJECT) in FY 2019/2020; and

WHEREAS, the DEPARTMENT agrees to increase the JPA funding amount by One Hundred Sixteen Thousand Six Hundred Sixty-Nine Dollars (\$116,669.00) to match the COUNTY's construction increase.

Section 2.1 is amended as follows:

The DEPARTMENT agrees to reimburse the COUNTY up to the maximum amount of One Million Three Hundred Seventy-One Thousand Eight Hundred Eighty-Nine Dollars (\$1,371,889.00) for completion of the PROJECT as provided in Exhibit "B".

Exhibit "B" is amended as follows:

- I. TOTAL ESTIMATED COST FOR CONSTRUCTION.....\$ 1,371,889.00
- II. PROJECT PARTICIPATION
 - FY 2019/2020 COUNTY Participation.....\$ 1,371,889.00
 - FY 2019/2020 State Participation.....\$ 116,669.00
 - FY 2021/2022 State payback\$ 1,255,220.00
- III. PROJECT funds are subject to legislative appropriation of available funds.
