Recap:

- Pinellas County Administration and Public Works is pleased to present the fully executed Jointly Procured Disaster Debris Collection and Removal Contracts. The contract # for all 7 vendors is 156-0491-P(JA).
- The pricing for each vendor begins on PDF page 31 for all 7 agreements. The pricing for CrowderGulf isn't legible, so it is attached to this email.
- The effective date of the agreement is August 7, 2017 and the end date is December 31, 2023.
- Attached is a spreadsheet that has the contact information for both the municipalities and the Collection vendors.
- The participant agreement is for municipalities to use in order to enter into the Collection contract as a participant with your selected vendors – hopefully all 7 which is to your benefit. The municipalities can modify the Participant Agreement to include their specific information, but they cannot modify the terms of the Cooperative Agreement through the use of the Participant Agreement. You can copy and paste the top section and bottom signature section multiple times to use one participants agreement for all seven contractors or individual participants agreement for each.

- We will be in communication about any coordination or training meetings once we have the participants agreements sent back. The monitoring contracts are still making their way through the County approval process.

PUBLIC RECORDS NOTICE: Under Florida law, e-mail addresses are public records. If you do not want your e-mail address released in response to a public records request, do not send electronic mail to this entity. Instead, contact this office by phone or in writing. Pursuant to FLORIDA STATUTE 119.12, public record requests to inspect or copy public records may be made to the city's custodian of public records, City Clerk Denise Kirkpatrick, 750 Milwaukee Ave., Dunedin, Florida 34698, or email: dkirkpatrick@dunedinfl.net, or phone (727) 298-3034 or facsimile (727) 298-3505. Pursuant to Florida Statute 119.12, if you wish to assert that you were denied access to inspect or copy a public record, you must provide a written notice to the city's custodian of records, identifying it as a public records request, at least five business days before filing a civil action. The notice period begins on the day the written notice of the request is received by the custodian of public records, excluding Saturday, Sunday, and legal holidays, and runs until 5 business days have elapsed. The contact information for the city's custodian of public records is posted in the city's primary administrative building in which public records are routinely created, sent, received, maintained, and requested and on the city's website.
