1. Opening of Meeting

Procedural: 1.1 Call to Order

The virtual meeting was called to order at 5:00 p.m. Mrs. Cook called the roll to confirm board members attendance on the virtual dais.

Mrs. Cook stated that we are in a unique time and our meeting has been adjusted to meet the circumstances. All comments submitted prior to the start of the meeting have been sent to all School Board Members and the Superintendent prior to the meeting. For all comments submitted after the start of the meeting but prior to the consideration of the relevant portion of the agenda, district staff will strive to immediately send them to the School Board Members and Superintendent. All public comments timely received will be appended to the meeting minutes.

The following individuals shared their comments, via the publiccomment@pcsb.org email address; which are captured below as written (there were no call-in public comments):

1. Margaret Chiou: (PCSB Teacher) There are a couple comments that I would like for the school board to consider in their upcoming virtual meeting. 1. About the unused personal days this year, in case this discussion has not been brought up yet. Due to the current health crisis most people don't get to use those days because we are told to stay home. It would be nice if we are allowed to carry over personal day entitlement into next year. 2. The teachers who earn a Highly Effective or Effective score, serving in Alternative schools should receive the same bonus money as all other teachers in the traditional schools. While it is true that our schools don't receive a grade but the teachers work just as hard if not more, as those other teachers while dealing with mostly at risk students on a daily basis. We are held to the same high standard of evaluation. Why aren't we receive the same recognition and being left out of this process? Please forward my comments if it is appropriate and helpful for the discussion. Thank you. (A district administrator responded to her questions.)

2. Rodney Russ: (PCSB Teacher) My name is Rodney Russ, and I am an English teacher at Disston Academy. I have taught nine years in Pinellas County. I addressed the school board during the February 25th meeting at Lakewood High School. I commented on the toxic and hostile work environment exhibited at Disston Academy during the 2019-2020 school term. Through our diligent efforts as a team, Disston Academy staff members were able to file a complaint against our school principal. We are awaiting the results of the findings. We are hopeful that the district will hear our pleas and do the right thing for our dedicated staff and students. After all, we are fighting to make genuine, positive changes for our students. No doubt, it's the reason we all became educators. Since speaking out, I have experienced bullying, harassment, and discrimination at the hands of Disston Academy administration team. Last month, slanderous and unfounded accusations were mailed out to me by principal in the form of a certified letter of caution. On Friday, April 24th, my contract was nonrenewed for unspecified reasons. Please ensure that all teachers are treated with respect and care. It is our duty as educators to stand up for the interests of the parents, fellow educators, and our students.

3. Lorena Grizzle: (PCSB Teacher) I came to you last year and asked for the Board to reconsider cutting a unit from Dunedin high school of a VE Teacher position. I tried to inform the Board of the unique needs of our school due to poverty. Nonetheless, you saw fit to cut our position. For speaking out, my former AP was unprofessional enough to complain to my colleagues that I had come to the Board to complain about my workload, which was not the case. Now I have been informed that yet another unit/VE position will be cut from Dunedin High School for the same reason as last year. This is 'to get the numbers correct', yet our incoming students match our outgoing students. The math does not add up. My colleagues and I have worked diligently all

year to lift our struggling students above the D's and F's that many have now and will have to take remedial and recovery credit classes to graduate. Some will not make it. We fend off potential lawsuits when students are not receiving their FAPE. I know our team is working 12 hour days to try and correct this and salvage this year with these students. Pleas take another look for our kids sake.

On behalf of the educators of Pinellas County, I respectfully ask that this Board adopt the resolution containing the ballot question necessary to continue the referendum that has benefitted the teachers and students of our District for the past 16 years.

Dear Pinellas County School Board:

The Physicians Committee for Responsible Medicine is a non-profit corporation that advocates for preventive medicine, supports higher ethical standards in research, and conducts clinical research, some of which is federally funded. The Physicians Committee's membership includes approximately 170,000 health care professionals and concerned individuals. The Physicians Committee submits this comment on behalf of its Pinellas County membership.

Since 2001, the Physicians Committee has issued a periodic "School Lunch Report Card," analyzing the nutritional quality of menus offered by the largest school districts participating in the National School Lunch Program. In 2007 and 2012, the most healthful school menus in the country were found in Pinellas County. The Physicians Committee also operates a related "Golden Carrot Awards" program, created in 2004 to recognize food service professionals who make an exceptional effort to improve the healthfulness of school lunches. In 2006, the program honored a food service director from Pinellas County.

A charter application submitted by KING Charter Schools is now before the School Board. As noted at <u>http://www.kingcharterschools.org/</u>, KING Charter seeks "to foster the positive and impactful engagement of our future generations ... based on a sophistically developed scholastic curriculum ... which also includes environmentally conscious and sustainable living, as well as healthy and whole foods eating[.]" As noted at <u>http://www.kingcharterschools.org/about-us/</u> students' "compassion and empathy will stem from our Plant-Based Curriculum and Cafeteria[.]"

Eating habits begin in early childhood. Providing healthful plant-based meals in schools sets an example for students to learn to enjoy a variety of nutritious foods from an early age. Plant-based meals provide excellent nutrition—they are rich in fiber, vitamins, minerals, and antioxidants that boost students' health. I am one of the founding board members for KING Charter Schools and have been with the project since the beginning. As a mother of a kindergartner, I started working on this project because of lack of options in the Pinellas County area that would meet our expectations and satisfy my child's needs. Over the past 2.5 years our team has researched every aspect of this application process and collectively, we bring dozens of years of experience in areas ranging from education, finance, marketing, legal, and much more. I have written and called your offices on multiple occasions requesting a time to speak or meet but no return calls or emails on your end were ever received from any of the PCSB members. What angers me is when I watch the December 10, 2019 board meeting and hear that Mr. Rick Wolfe met with each school board member individually to explain why we should be denied. Why was this offer not made to KING Charter board members? I hear Mr. Dudley say "these people.....are wasting 15 to 20 minutes" of his time. These people? Parents and community members in his district? 15-20min? Superintendent Grego and the Pinellas County School Board:

Thank you for your consideration of KING Charter School's application scheduled for the April 28th agenda. I am writing in my capacity as a founding board member of KING Charter School. The KING team has conducted extensive research and called on the expertise of education professionals over the past two and a half years as we developed and revised our application. Our vision is to establish a trilingual (Spanish, Mandarin, and English) immersion school with a focus on environmental responsibility and sustainability to serve the Pinellas County community. We chose to focus on these two global issues – trilingual immersion and environmental responsibility – to meet the needs of students as global citizens.

I appreciate the time and effort of the review team in evaluating our application and would like to respond to some of their comments that do not accurately represent the contents of the application:

• During the 4/8/20 capacity interview, KING board members explained that edits had been made to address concerns about coherence, and some information had been reorganized and moved among sections. Our purpose was to address components identified as missing by the reviewers; these components were not missing – they were addressed in other sections of the application – so we moved that information in the current application to better reflect the reviewers' expectations and for ease of locating the specific components.

• During the 4/21/20 workshop, one reviewer stated there was "no clear and coherent program design; no curriculum plan; no specific curriculum outline, resources, or materials; and no evidence of emphasis on reading instruction." Each of these components was included in the previous applications; however, in an effort to more thoroughly and coherently address these concerns based on feedback from the previous submission, we edited the narrative text of the application to more clearly indicate how these aspects are addressed and to indicate where some of these components were addressed in the attachments:

 \circ The program design, curriculum framework, and plans for assessment and accountability are thoroughly addressed in Sections 1 – 5.

○ Attachment C is a complete K – 5 science curriculum scope and sequence, including a curriculum plan/pacing guide for each grade level, instructional materials, and digital resources, with alignment to the Florida Next Generation Sunshine State Standards.

 Attachment D describes the K – 1 reading curriculum based on the Language Arts Daily Components and Five Areas of Reading designated by the Pinellas County School District, and identifies the Journeys Series as the instructional materials resource; this is the adopted reading text of Pinellas County School District.

Community members and educators have expressed support for KING Charter School's vision and unique focus on an eco-friendly trilingual immersion school preparing students for global citizenship. We respectfully submit our application and we believe it to be complete, coherent, and meeting the Florida Department of Education criteria. As a retired Florida public school teacher and state education administrator with experience and passion for improving teaching and learning for all students, I appreciate your review and consideration as we all work towards continuous improvement of education opportunities and fostering skills our students will need to be successful and responsible global citizens.

King Charter School has been denied more than once and we, as a board, are going to keep swinging. It is difficult to put into words the genuineness each board member has for this school, what it means to us individually, what it means to our children, and what it means for our community – as well as what it could mean for other communities throughout the United States. We are seeking guidance in what areas need to be addressed in order to get this school started and underway.

Some of the main concerns that Rick Wolfe and his advisory team have are a lack of understanding with the application. Sections of concern to Rick Wolfe and his advisory team include curriculum, budget, and the board members approach to starting a Florida charter school. While addressing every portion would take up some time, the main topic of this letter is the budget. The budget is sound and gives leniency in most parts. The budget is very detailed and gives a broad understanding and supports the application.
