# EMERGENCY SOLUTIONS GRANT PROGRAM - CORONAVIRUS RESPONSE PROGRAM SUBAWARD SPECIFIC PERFORMANCE AGREEMENT WITH HOMELESS LEADERSHIP ALLIANCE OF PINELLAS, INC. (ESGCV19HLA)

THIS SECOND AMENDMENT TO THE EMERGENCY SOLUTIONS GRANT - CORONAVIRUS RESPONSE PROGRAM SUBAWARD SPECIFIC PERFORMANCE AGREEMENT (AMENDMENT), is made and entered into by and between **Pinellas County** (**COUNTY**), a political subdivision of the State of Florida, having its principal office at 315 Court Street, Clearwater, Florida 33756, and **Homeless Leadership Alliance of Pinellas, Inc.** (**AGENCY**), a not-for-profit corporation organized under the laws of the State of Florida, having its principal office 647 1<sup>st</sup> Avenue North, St. Petersburg, Florida 33701:

### WITNESSETH:

WHEREAS, March 15, 2022, **COUNTY** entered into Emergency Solutions Grant Program Subaward Specific Performance Agreement, Agreement No.: **ESGCV19HLA** (AGREEMENT) with AGENCY to provide, through the Pinellas County Housing and Community Development Department (DEPARTMENT), **\$73,769.43** (**Seventy-Three Thousand, Seven Hundred Sixty-Nine and 43/100 Dollars)** in Emergency Solutions Grant — Coronavirus Response (ESG-CV) funds to **AGENCY** to provide homelessness prevention services to eligible individuals or families to prevent, prepare for, and respond to COVID-19 (hereinafter the PROJECT); and

WHEREAS, on November 7, 2022, COUNTY executed a First Amendment to AGREEMENT with AGENCY, wherein the COUNTY extended the term of the specific performance period six months; and

WHEREAS, the AGREEMENT states that PROJECT activities shall be completed by the AGREEMENT expiration date of March 31, 2023; and

WHEREAS, the AGENCY, will not be able to complete the PROJECT on or before the AGREEMENT expiration date of March 31, 2023; and

WHEREAS, the AGENCY has requested, and the COUNTY has agreed, to extend the AGREEMENT expiration date, six (6) months to **September 30, 2023**, to allow the PROJECT to continue providing needed services; and

NOW, THEREFORE, in consideration of the promises and mutual covenants, contained herein and for other good and valuable considerations, the receipt and sufficiency of which are hereby mutually acknowledged, the parties agree as follows:

**Article 1. Recitals.** The above recitals are true and correct and are incorporated herein by reference.

**Article 2. Amended Terms and Conditions.** The terms and conditions of the AGREEMENT are hereby amended and restated as follows:

## 3. TERM OF SPECIFIC PERFORMANCE AGREEMENT; EFFECTIVE DATE

This Agreement shall become valid and binding upon proper execution by the parties hereto, and unless terminated pursuant to the term herein, shall continue in full force and effect until

September 30, 2023, or until COUNTY'S full and complete disbursement of funding to AGENCY, whichever comes first. AGENCY may use funds provided herein to cover eligible PROJECT expenses incurred by the AGENCY between March 1, 2022 and September 30, 2023.

Article 3. Terms and Conditions. Except as otherwise stated herein, the terms and conditions of the Agreement shall remain in full force and effect.
