The noise and activity from large groups—along with more cars parked on the street and constant comings and goings—take away from the safe environment that neighborhoods provide. In communities where residents value knowing their neighbors, these disruptions can lead to sleep loss and stress, especially when people have work the next day. As a life-long Pinellas County resident, it has become obvious to me that there are many problems with short-term rentals, such as Airbnb, in family neighborhoods.

The current ordinances are bad enough— we have had problems in our neighborhood such as— the inability of emergency vehicles, such as fire trucks, to access our street due to too many parked cars . . . excessive noise that interferes with residents ability to sleep . . . and inappropriate (and even lewd) behavior from STR renters. We should not relax the current ordinances at the expense of single family residents.

Short-term rentals are businesses and should be treated as such.

There is a reason that hotels are not zoned in non-commercial neighborhoods.

The homes we are referencing are short-term rentals advertised as resort-style party destinations. While we appreciate

your efforts with File: 25-0051A and agree that further regulation is required, there are some major holes in the final document.

1. Removing children 12 and under from an occupancy count is ridiculous, unsafe, and creates a hazard. This is not consistent with annual rental regulations or hospitality regulations.
2. Further limiting quiet hours is an affront to the peaceful enjoyment of our homes. Allowing these people to party until 11 pm on a Sunday is offensive.
3. Inspections of the properties every 2 years are not frequent enough. Hospitality properties in Florida have 2-3 unannounced inspections per year.

We do not have issues with families vacationing in these homes and respecting the neighborhood, but we are sick of living next to these businesses with high-intensity uses. As your constituents, we desperately need your help in getting our neighborhood back.

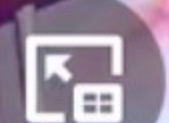
