Applying to the mask policy/lower cases premise;




This logical fallacy can also be applied in reverse in order to show how fallacious a logic it really is:

In times of COVID metric downturns, and citing just the mask policy being in existence as the reason for the downturns is the logical fallacy of Correlation is Causation. This fllacy, applied the other way, can be seen here in that there was high mask compliance, but instead, significant COVID metric upturns occured. So taking the position that high compliance causes upturns in this case would also be the same "correlation is causation" logical fallacy, just applied the other way.





So stating that high mask compliance CAUSES COVID upturns, absent a scientific nexus, is just as much a logical fallacy as stating that a mask policy causes downturns, just because of the overlapping dates between the two data sets.

The people who write these types of papers know this and slickly insert the words, "associated with" to cover themselves, so they will write something along the lines of, "The school mask policy was 'associated with' lower case numbers'.

Again, nothing herein is stated that there is a causal relationship between NPI compliance and enforcement with the COVID upturns. To do so would be the logical fallacy of equating correlation with causation in the

same way a government could take credit by citing a causal relationship between their mask/NPI policy, with that of COVID downturns and calling their policy successful just due to the overlapping of dates between the two events, as already exhausted.

It is unfair and intellectually dishonest to,

A. on one hand, state that the mask policy is successful because covid downturns happened during the same time, BUT

As we are all admonished not to "cherry pick" data, then other studies by legitimate sources should be considered in the interests of fairness and intellectual honesty.

Commissioner Flowers, as one who is the representative of my district, you said that you favor facts over emotions, so I will hold you to that standard and see if you really do exercise such a sentiment.

Dr. Choe, as someone who has been reported to have advanced behavioral health in the county, it's confounding how you could overlook the following citations regarding the mental health damages masks can cause to children. The masking of children could wind up costing Pinellas much in terms of funding the mental health diagnoses in the area.

Commissioner Seel, as one who favored Dr, Choe's school example, hopefully you will exercise consistency in your decisions by considering these school examples as well without bias.

- 1. The school systems in Sweden and Denmark do not require masks, and it has shown that youth are not likely to become severely affected by the virus, nor are they as likely to transmit.
- A. There was no higher rate of infection among school children in Sweden, who had no schoolwide mask mandate, and whose schools were never closed for children under 16 years old, rather than in Finland, whose schools remained closed during the pandemic.

C. Regarding Denmark schools, The article entitled, <u>No masks</u>, <u>no distancing: Schools in Denmark defy COVID-19 — with success so far</u> features Allan Randrup Thomsen, a virologist at the University of Copenhagen who stated,

"Most of the evidence points to the fact that even if children become infected, they are not getting severely diseased and they also don't transmit the disease," Randrup Thomsen said, although he admitted much remains unknown."

- 2. The totality of damages that can be done to masked children outweigh any perceived benefits to them or others than if they are NOT coerced into being masked.
- A. The risks of transmission to teachers and the elderly and contracting severe illness are low in children
 - The Annals of Epidemiology stated that there was no additional household risk for those over 70 in Stockholm associated with co-residing with children still in school during the pandemic.

- B. Since there is competent scientific proof from legitimate, peer reviewed sources demonstrating that unmasked children are less likely to transmit Sars-Cov-2 to the elderly residing with them, or to school teachers, or to develop severe COVID-19, the neurological damages masking can cause to children far outweigh any benefits to coercing them into masking:
